- 8. In Arizona Test Method 245, "MAXIMUM DRY DENSITY AND OPTIMUM MOISTURE OF SOILS BY ALTERNATE METHOD D PROCTOR, in section 7(b) please change "0.5 percent" to "0.1 percent". In section 7(c) of this test procedure, please change "0.5 lb./cu. ft." to "0.1 lb./cu. ft.".
- 9. Several manuals have a typographical error in Arizona Test Method 410c, "COMPACTION AND TESTING OF BITUMINOUS MIXTURES UTILIZING 101.6 mm (FOUR INCH) MARSHALL APPARATUS". In section 2(c)(1) of this test procedure, if your manual shows "4563.0", please change it to read "4536.0".
