Cost of Underage Drinking

Excessive Drinking is responsible for **4,300** deaths in underage youth each year





Costing **\$24 Billion** in economic cost



Average age of first alcohol use in Arizona is 12

Children who drink before the **age of 15** are **5 times more likely to become addicted**

90% of teen drinking is binge drinking

Adverse Childhood Experiences Could Lead to Underage Drinking

<u>Physical Abuse</u>: Includes injuries or bruising from being punched, kicked, stabbed, shaken or hit with an object. These injuries could come from a parent, family member or caregiver. Studies show that male children are more likely to suffer physical abuse than females.

<u>Sexual Abuse</u>: More than 16 percent of males and 24.7 percent of females experience childhood sexual abuse. This form of abuse can include incest, rape, fondling, and indecent exposure by a parent, relative, or caregiver.

Emotional Abuse: Surprisingly, girls are more likely to experience emotional abuse than boys are. This kind of abuse includes humiliation, threats of abandonment or punishment, berating, disparaging remarks, and confinement or isolation for long periods.

Neglect: More than 686,000 kids are abused or neglected each year in the US. Neglect includes lack of supervision, abandonment, malnutrition, and failure to provide basic daily needs. According to a survey by ACE researchers, as many as 25.9 percent of girls and 23.1 percent of boys experience child neglect.



Concerns for Gateway Drugs - Marijuana

- Loss of attention
- Impaired learning ability
 - Decreased memory functions
- Impaired Judgment and decision-making
- Escalate to harder drugs
- Focus on academics and responsibilities decreases

Underage Consequences

School problems, such as higher absence and poor or failing grades

Social problems, such as fighting and lack of participation in youth activities

Legal problems, such as arrest for driving or physically hurting someone while drunk

Physical problems, such as hangovers or illnesses

Unwanted, unplanned, and unprotected sexual activity



Dangers of Binge Drinking



Unintentional injuries (e.g. car crash, falls, burns, drowning).

Intentional injuries (e.g. firearm injuries, sexual assault, domestic violence).

Alcohol poisoning.

STD's and/or Unintended pregnancy.

High blood pressure, stroke, and other cardiovascular diseases.

Liver Disease

Drinking and Driving

Drinking alcohol impairs vision, reaction time, and coordination

Alcohol related incidents are the leading cause of death among teens

Signs of intoxication can begin to appear as low as 0.02 BAC

There is no acceptable BAC level for anyone under 21
