4 **“Addenda/Addendum”** means supplemental additions, deletions, and modifications to
5 the provisions of the RFP after the release date of the RFP.

6 **“ADOT State Engineer”** means the individual serving in the position of state engineer
7 for ADOT pursuant to Arizona Revised Statutes, section 28-6921, and appointed by the
8 ADOT Director as the ADOT Deputy Director of Transportation.

9 **“Alternative Technical Concepts”** or **“ATCs”** means the concepts described in ITP
10 Section 3.1.

11 **“Arizona Department of Transportation”** or **“ADOT”** means the Arizona Department
12 of Transportation, an agency of the State of Arizona.

13 **“Authorized Representative”** has the meaning set forth in ITP Section 2.2.1.

14 **“Best Value”** means evaluation and selection of Proposals based on consideration of
15 price and other key factors.

16 **“Buy America”** means the Buy America requirements set forth in 23 CFR 635.410.

17 **“Closing Documents”** has the meaning set forth in ITP Section 6.1.2.

18 **“Conditional Award”** means issuance of notification from the Authorized
19 Representative to the Proposers of the decision on rankings, on the Preferred Proposer,
20 and on intended award of the DBM Agreement.

21 **“Contract Documents”** means the “Contract Documents” defined in Section 1.2 of the
22 DBM Agreement, some of which are set forth in Volume II of the ITP.

23 **“D&C Payment Bond”** means a bond in the form of Exhibit 9-2 to the ITP.

24 **“D&C Performance Bond”** means a bond in the form of Exhibit 9-1 to the ITP.

25 **“D&C Price”** means the total price for the D&C Work from the bottom of Form M-2 of
26 Exhibit 5 to the ITP.

27 **“DBE Goals”** means the ADOT goals for Disadvantaged Business Enterprise
28 participation on the Project set forth in ITP Section 1.10.3.

29 **“DBM”** means design-build-maintain.

30 **“DBM Agreement”** means the Design-Build-Maintain Agreement, as further set forth in
31 Volume II of the RFP.

1 **“DEIS”** means the draft environmental impact statement for the Project, as further
2 described in ITP Section 1.5.1.

3 **“Detailed Pricing Documents”** or **“DPDs”** has the meaning set forth in ITP Section
4 5.12.4.

5 **“Developer”** means the entity identified in the successful Proposal to enter into the
6 DBM Agreement and design, construct and maintain the Project.

7 **“Design & Construction Price”** or **“D&C Price”** has the meaning set forth in Section
8 3.1 of Exhibit 4 to the ITP.

9 **“Equity Member”** means (a) each entity with a direct interest in the Proposer (whether
10 as a member, partner, joint venture member, or otherwise), (b) each entity proposed to
11 have a direct interest in Developer (whether as a member, partner, joint venture
12 member, or otherwise), and (c) each entity that will have an indirect interest in the
13 Proposer or Developer through one or more intermediaries. Notwithstanding the
14 foregoing, if the Proposer is a publicly traded company, shareholders with less than a
15 10% interest in the Proposer shall not be considered Equity Members.

16 **“Evaluation and Recommendation Committee”** or **“ERC”** means either the Financial
17 Evaluation and Recommendation Committee or the Technical Evaluation and
18 Recommendation Committee.

19 **“Executive Summary”** means the executive summary meeting the requirements of
20 A.R.S. section 28-7707(B) and submitted with the Technical Proposal providing the
21 information requested in Section 3.1 of Exhibit 2 to the ITP.

22 **“Factored Annual Maintenance Price”** has the meaning set forth in ITP Section 5.6.

23 **“FEIS”** means the final environmental impact statement for the Project, as further
24 described in ITP Section 1.5.1.

25 **“Financial Evaluation and Recommendation Committee”** or **“FERC”** means the
26 committee that performs the responsiveness and pass-fail review of the Financial
27 Proposals and Price Proposals, and evaluates the Price Proposals, for recommendation
28 to the Selection Official as set forth in ITP Section 5.1.

29 **“Financial Proposal”** means the financial information included in a Proposal submitted
30 by a Proposer providing the information requested in Exhibit 3 of the ITP.

31 **“Financial Proposal Advisory Group”** or **“FPAG”** means the advisory group ADOT
32 forms to perform initial review of the Financial Proposals and Price Proposals and to
33 assist the Financial Proposal Evaluation Committee.

34 **“Instructions to Proposers”** or **“ITP”** means the documents, including exhibits and
35 forms, included in the RFP as Volume I, containing directions for the preparation and
36 submittal of information by the Proposers in response to the RFP.

- 1 **“Key Personnel”** means the individuals designated by a Proposer in its SOQ or
2 pursuant to ITP Section 2.10.
- 3 **“Key Professional Services Firm”** means each firm, other than an Equity Member or
4 Major Non-Equity Member, that will provide engineering, architectural, surveying,
5 planning, quality assurance, ROW acquisition, appraisal, and/or other professional
6 services for development of the Project valued at \$5 million or more.
- 7 **“Last Allowable Date for Final Acceptance”** means the date so indicated on Form O
8 of Exhibit 5 to the ITP.
- 9 **“Last Allowable Date for Substantial Completion”** means the date so indicated on
10 Form O of Exhibit 5 to the ITP.
- 11 **“Lead Engineering Firm”** means the member of the Proposer team, whether a single
12 entity or joint venture, primarily responsible for the design and engineering of the
13 Project. The Lead Engineering Firm will be the Developer’s engineering firm of record
14 with primary responsibility for design work under the DBM Agreement.
- 15 **“Lead Maintenance Firm”** means the member of the Proposer team, whether a single
16 entity or joint venture, primarily responsible for performance of the maintenance
17 services for the Project.
- 18 **“Lead Subcontractor”** means the member of the Proposer team, whether a single
19 entity or joint venture, primarily responsible for the construction of the Project.
- 20 **“Legal Advisory Group”** means the group of ADOT’s legal counsel who will assist and
21 advise ADOT with respect to execution of the Proposal evaluation and scoring process.
- 22 **“Maintenance NTP”** means a fourth notice to proceed with maintenance of the Project
23 as described in ITP Section 1.6.3.
- 24 **“Maintenance Price”** means the sum of the total numbers calculated in column F of
25 Form N-1.1 and in column J of Form N-1.2 of Exhibit 5 to the ITP.
- 26 **“Major Non-Equity Member”** means the following members of the Proposer team, if
27 such team members are not Equity Members:
- 28 (a) the Lead Engineering Firm (if a consortium, partnership or any
29 other form of a joint venture, all such members);
- 30 (b) the Lead Subcontractor (if a consortium, partnership or any other
31 form of a joint venture, all such members);
- 32 (c) any firm, other than the Lead Subcontractor, that will be responsible
33 for 20% or more of the construction work on the Project; and
- 34 (d) the Lead Maintenance Firm (if a consortium, partnership or any
35 other form of a joint venture, all such members).

1 **“Maximum Allowable Cumulative Draw”** means the schedule of maximum cumulative
2 progress payments of the D&C Price set forth in Exhibit 6 to the DBM Agreement and in
3 column F of ITP Form M-2.

4 **“NTP 1”** means an initial notice to proceed with certain Work as described in ITP
5 Section 1.6.3.

6 **“NTP 2”** means a second notice to proceed with design and construction Work, except
7 construction and other ground disturbing Work in the Center Segment, as described in
8 ITP Section 1.6.3.

9 **“NTP 3”** means a third notice to proceed with construction and other ground-disturbing
10 Work in the Center Segment as described in ITP Section 1.6.3.

11 **“OJT”** means on-the-job training for minorities, women, veterans and disadvantaged
12 individuals.

13 **“OJT Goals”** means the ADOT goals for on-the-job training on the Project for
14 minorities, women, veterans and disadvantaged individuals set forth in ITP Section
15 1.10.8.

16 **“Post-Selection Deliverables”** has the meaning set forth in ITP Section 5.12.

17 **“Preferred Proposer”** means the best value Proposer, as evidenced by being the
18 highest scoring Proposer based on the best value determination pursuant to
19 ITP Section 5.2, or any next most highly ranked Proposer, and so on, with whom ADOT
20 elects to conduct negotiations.

21 **“Preliminary Aesthetics and Landscape Master Plan”** is the preliminary plan for
22 aesthetics and landscape for the Project required to be submitted with the Proposal and
23 meeting the requirements set forth in Section 4.1.3.5 of Exhibit 2 to the ITP.

24 **“Preliminary ATCs”** means preliminary concepts described in ITP Section 3.3.

25 **“Preliminary DBE Utilization Plan”** is the preliminary plan for utilizing DBEs required
26 to be submitted with the Proposal and meeting the requirements set forth in Section
27 4.2.7.2 of Exhibit 2 to the ITP.

28 **“Preliminary Environmental Management Plan”** is the preliminary plan for achieving
29 compliance with environmental laws, permits and approvals, including the
30 environmental mitigation measures adopted with the ROD, required to be submitted
31 with the Proposal and meeting the requirements set forth in Section 4.2 of Exhibit 2 to
32 the ITP.

33 **“Preliminary Maintenance Management Plan”** is the preliminary plan for maintaining
34 the Project required to be submitted with the Proposal and meeting the requirements set
35 forth in Section 4.2 of Exhibit 2 to the ITP.

1 **“Preliminary OJT Utilization Plan”** is the preliminary plan for on-the-job training
2 required to be submitted with the Proposal and meeting the requirements set forth in
3 Section 4.2.7.6 of Exhibit 2 to the ITP.

4 **“Preliminary Project Baseline Schedule”** is the time-scaled, Critical Path network that
5 depicts Project sections, Project milestones, and subordinate activities and their
6 respective durations, sequencing, and interrelationships that represent the Proposer’s
7 Work plan for designing, constructing, and completing the Project, required to be
8 submitted with the Proposal and meeting the requirements set forth in Section 4.2.2 of
9 Exhibit 2 to the ITP.

10 **“Preliminary Project Management Plan – Project Administration Chapter”** is the
11 preliminary plan for managing and administering the Project required to be submitted
12 with the Proposal and meeting the requirements set forth in Section 4.2.1 of Exhibit 2 to
13 the ITP.

14 **“Preliminary Quality Management Plan”** is the preliminary plan for managing the
15 quality of the Work required to be submitted with the Proposal and meeting the
16 requirements set forth Section 4.3 of Exhibit 2 to the ITP.

17 **“Preliminary ROW Activity Plan”** is the preliminary plan for meeting right-of-way
18 performance requirements and performing right-of-way services for the Project required
19 to be submitted with the Proposal and meeting the requirements set forth in Section
20 4.2.3 of Exhibit 2 to the ITP.

21 **“Preliminary Safety Management Plan”** is the preliminary plan for ensuring the safety
22 of workers and the public during Project construction required to be submitted with the
23 Proposal and meeting the requirements set forth Section 4.2.6 of Exhibit 2 to the ITP.

24 **“Pre-Proposal Submittal”** has the meaning set forth in ITP Section 2.4.

25 **“Price Proposal”** means the price offer included in the Proposal submitted by a
26 Proposer consisting of the items set forth in Exhibit 4 of the ITP.

27 **“Price Score”** has the meaning set forth in ITP Section 5.2.1.

28 **“Price Value”** has the meaning set forth in ITP Section 5.6.

29 **“Procurement Advisory Group”** or **“PAG”** means either the Technical Procurement
30 Advisory Group or the Financial Procurement Advisory Group.

31 **“Project Delivery Approach”** means the portion of the Technical Proposal providing
32 the information requested in Section 4.2 of Exhibit 2 to the ITP.

33 **“Project Development Plan”** means the Technical Proposal described in Section 4.0
34 of Exhibit 2 to the ITP, consisting of the Technical Approach, Project Delivery Approach
35 and Quality Management Approach.

36 **“Proposal”** means the original documents submitted by a Proposer in response to the
37 RFP, as further described in ITP Section 1.8.1.

- 1 **“Proposal Bond”** means a bond to secure the obligations of a Proposer under the ITP,
2 as more particularly described in ITP Section 4.4.1.
- 3 **“Proposal Due Date”** means the deadline for submission of the Proposals identified in
4 ITP Section 1.7.
- 5 **“Proposal Letter”** means the letter to be submitted with each Proposal in the form of
6 Form A of Exhibit 5 to the ITP.
- 7 **“Proposal Letter of Credit”** means a letter of credit to secure the obligations of a
8 Proposer under the ITP, as more particularly described in ITP Section 4.4.2.
- 9 **“Proposal Revisions”** have the meaning set forth in ITP Section 5.9.
- 10 **“Proposal Security”** means either a Proposal Bond or a Proposal Letter of Credit.
- 11 **“Proposer”** means an entity that ADOT shortlisted for competing for the Project based
12 on ADOT’s evaluation of SOQs delivered to ADOT on December 10, 2014, in response
13 to the RFQ.
- 14 **“Proposer’s Schematic Design”** means the portion of the Technical Proposal
15 providing the information requested in Section 4.1.1 of Exhibit 2 to the ITP.
- 16 **“Quality Management Approach”** means the portion of the Technical Proposal
17 providing the information requested in Section 4.3 of Exhibit 2 to the ITP.
- 18 **“Request for Proposals”** or **“RFP”** means the set of documents identifying the Project
19 and the work to be performed and materials to be furnished in response to which a
20 Proposal may be submitted by a Proposer. The RFP includes the ITP, Contract
21 Documents and Reference Information Documents. The RFP is issued only to
22 Proposers that have been shortlisted following SOQ review.
- 23 **“Request for Qualifications”** or **“RFQ”** means ADOT’s Request for Qualifications for
24 the Project issued on October 15, 2014, as amended.
- 25 **“Retained Parcels”** means the parcels for which ADOT will retain responsibility for
26 acquisition, relocation and demolition work, as more specifically identified in the
27 Acquisition/Relocation Status Report contained in the Reference Information
28 Documents as the same may be updated with the last Addendum to the RFP.
- 29 **“ROD”** means the record of decision that the FHWA published for the Project, as
30 further described in ITP Section 1.5.1.
- 31 **“Selection Official”** means the ADOT official who will make the ranking and best value
32 determinations and select the Preferred Proposer, subject to ratification by the ADOT
33 State Engineer.
- 34 **“Small Business Concern”** or **“SBC”** has the meaning set forth in ITP Section 1.10.6.

1 **“SOQ”** means the statement of qualifications submitted by a Proposer to ADOT
2 pursuant to the RFQ, including all clarifications thereto submitted in response to
3 requests by ADOT.

4 **“Stakeholder”** means (a) parties, other than ADOT, that may have a stake in the
5 Project by virtue of their location or funding, including the Maricopa Association of
6 Governments, the City of Phoenix, the Gila River Indian Community (which includes all
7 associated units of government, businesses and enterprises, as well as all property
8 owners and lessees within its jurisdiction), the Salt River Pima-Maricopa Indian
9 Community (which includes all associated units of government, businesses and
10 enterprises, as well as all property owners and lessees within its jurisdiction), business
11 and property owners associated with the Project, Utility Owners with facilities associated
12 with the Project, Union Pacific Railroad, and (b) state and federal Governmental Entities
13 with jurisdiction over the Project, such as U.S. Army Corps of Engineers, Federal
14 Highway Administration, and U.S. Fish and Wildlife Service. For purposes of ITP
15 Section 2.2.3(e), the Arizona Department of Public Safety and any other public law
16 enforcement agency (other than the City of Phoenix police) with jurisdiction to provide
17 traffic patrol, traffic law enforcement and other police and public safety services in
18 accordance with applicable laws and agreements with State and local agencies will not
19 be considered Stakeholders.

20 **“Stipend Agreement”** means the agreement between Proposer and ADOT set forth as
21 ITP Exhibit 10 that governs the payment for work product and use of the Proposer’s
22 work product, if unsuccessful, in accordance with ITP Section 6.3.

23 **“Surety”** means the individual or entity committing to provide any of the bonds
24 identified in the RFP.

25 **“Technical Approach”** means the portion of the Technical Proposal providing the
26 information requested in Section 4.1 of Exhibit 2 to the ITP.

27 **“Technical Evaluation and Recommendation Committee”** or **“TERC”** means the
28 committee that performs the responsiveness and pass-fail review of the Technical
29 Proposals, and evaluates the Technical Proposals, for recommendation to the Selection
30 Official as set forth in ITP Section 5.1.

31 **“Technical Proposal”** means all of the documents, certifications and information
32 required to be submitted pursuant to Exhibit 2 to the ITP.

33 **“Technical Proposal Advisory Group”** or **“TPAG”** means the advisory group ADOT
34 forms to perform initial review of the Technical Proposals and to assist the Technical
35 Proposal Evaluation Committee.

36 **“Technical Score”** has the meaning set forth in ITP Section 5.2.2.

37 **“Total Proposal Score”** has the meaning set forth in ITP Section 5.2.

38 **“Work Product”** has the meaning set forth in ITP Section 6.3 and in Section 1(b)(i) of
39 Exhibit 10 to the ITP.

- 1 For definitions of other initially capitalized terms and for acronyms, see Exhibit 1 to the
- 2 DBM Agreement.

2 TECHNICAL PROPOSAL INSTRUCTIONS

3
4 **SECTION 1 GENERAL INSTRUCTIONS**

5 This Exhibit 2 describes the submission format for Technical Proposals and outlines the
6 required information that will comprise a Technical Proposal.

7 Proposer shall submit the information required by this Exhibit 2 in the organization and
8 format specified herein. The Technical Proposal shall be organized in the order listed in
9 Exhibit 6, and shall be clearly indexed. Each component of the Technical Proposal shall
10 be clearly titled and identified.

11 All forms named herein are found in Exhibit 5, unless otherwise noted. All blank spaces
12 in the Proposal forms must be filled in as appropriate. No substantive change shall be
13 made in the Proposal forms.

14 **SECTION 2 FORMAT**

15 The Technical Proposal shall be limited to the aggregate number of pages indicated in
16 Exhibit 6, plus the executive summary, resumes, appendices and exhibits containing
17 required forms, graphs, matrices, schedule, drawings and other pertinent data. Page
18 limits for each element of the Technical Proposal may be found in Exhibit 6.

19 **SECTION 3 CONTENTS OF THE TECHNICAL PROPOSAL**

20 The required contents and organization of the Technical Proposal are presented in this
21 Exhibit 2 and summarized in the Format and Organization of Proposal and Pre-Proposal
22 Submittals provided in Exhibit 6. Proposers are to provide all the information set out in
23 this Exhibit 2. A copy of the Exhibit 6 checklist for the Technical Proposal shall be
24 included in the Technical Proposal. Proposer shall not amend the order or change the
25 contents of the checklist except to provide the required cross reference to its Proposal.

26 The Technical Proposal shall consist of the following major elements:

- 27 a) Executive Summary;
- 28 b) Proposer Information, Certifications and Documents (including required Forms A,
29 B (Parts 1 through 5), C, D, E, F, H-1, H-2, H-3, H-4, H-5, H-6, H-7, H-8, I-1, I-2,
30 J, O, P, Q, R, and S);
- 31 c) Project Development Plan; and
- 32 d) Appendices

33 **3.1 Executive Summary**

34 The Executive Summary shall be written in a non-technical style and shall contain
35 sufficient information for reviewers with both technical and non-technical backgrounds to
36 become familiar with Proposer's Proposal and Proposer's ability to satisfy the financial

1 and technical requirements of the Project. The Executive Summary shall not include
2 any information regarding pricing or cost information, or other confidential or proprietary
3 information or trade secrets that the Proposer intends to be exempt from disclosure. It
4 shall, at a minimum, include the following:

- 5 a) An explanation of the organization and contents of the Proposal.
- 6 b) A summary of any changes to Proposer's SOQ.
- 7 c) A summary of any changes in Proposer's organization, in accordance with ITP
8 Section 2.10.
- 9 d) A summary of the proposed management, decision making, and day-to-day
10 operation structure of Proposer, and a statement that each Equity Member and
11 Major Non-Equity Member has committed to provide the specified people;
- 12 e) A summary of the Project Development Plan, which shall include: (i) Technical
13 Approach summary; (ii) Project Delivery Approach summary; and (iii) Preliminary
14 Quality Management Plan summary; and
- 15 f) A summary of the Proposer's approach to satisfying the DBE and OJT
16 requirements.

17 **3.2 Proposer Information, Certifications and Documents**

18 **3.2.1 Proposal Letter**

19 The Proposal shall include the Proposal Letter (Form A). Proposer shall attach to the
20 Proposal Letter the documents and information described in the section entitled
21 "Additional Information To Be Provided With Proposal Letter" of Form A.

22 **3.2.2 Proposer's Organization Information**

23 The Proposal shall include a completed Proposer Team Summary and Certification
24 chart on Form B, Part 1, including the names and contact information for Proposer and
25 Developer, including Equity Members, Major Non-Equity Members, Guarantor(s), Major
26 Professional Services Firms and other Subcontractors, except other Subcontractors that
27 have a contract price, per Subcontractor, less than 1% of the total D&C Price (if performing
28 D&C Work) or less than 1% of the total Maintenance Price (if performing Maintenance
29 Services).

30 The Proposal shall include Team Member Information, Form B, Part 2, for the Proposer,
31 Developer, each Equity Member, each Major Non-Equity Member, each Guarantor,
32 each Major Professional Services Firm, each Key Subcontractor and other
33 Subcontractors, except other Subcontractors that have a contract price, per
34 Subcontractor, less than 1% of the total D&C Price (if performing D&C Work) or less than
35 1% of the total Maintenance Price (if performing Maintenance Services).

36 The Proposal shall include completed Form B, Part 3 identifying Changes in Proposer's
37 Organization and Key Personnel, pursuant to ITP Section 2.10. The Proposal shall also
38 include the required attachments of Form B, Part 3.

1 The Proposal shall include completed Form B, Part 4 indicating Licenses and
2 Registrations for each Equity Member, Major Non-Equity Member, Major Professional
3 Services Firm, other identified Subcontractors, except other Subcontractors that have a
4 contract price, per Subcontractor, less than 1% of the total D&C Price (if performing D&C
5 Work) or less than 1% of the total Maintenance Price (if performing Maintenance
6 Services), and Key Personnel. The Proposal shall also include the required
7 attachments of Form B, Part 4.

8 The Proposal shall include completed Form B, Part 5 regarding Surety Information.

9 **3.2.3 Certification / Questionnaire**

10 The Proposal shall include Form C, the Certification / Questionnaire, signed by
11 Proposer, each Major Equity Member and Major Non-Equity Member. Use a separate
12 Form C for each entity. The Proposal shall also include the required attachments of
13 Form C.

14 **3.2.4 Updated Industrial Safety Record for Construction Work**

15 The Proposal shall include an updated industrial safety record on Form D for each
16 Equity Member and each Major Non-Equity Member of Proposer's team that will
17 perform or supervise installation and/or construction work on the Project. Use a
18 separate Form D for each entity. If any such entity does not have an industrial safety
19 history (for example if the firm is newly formed), Form D is not required for such entity,
20 but a statement shall be provided explaining why the form is not included.

21 **3.2.5 Key Personnel**

22 **3.2.5.1 Key Personnel Information**

23 See ITP Section 2.10 for information on ADOT approval of changes in Key Personnel.
24 The Proposal shall include Form E identifying personnel work assignments, as well as
25 signed commitments of availability.

26 Refer to the Contract Documents, as applicable, for information regarding time
27 commitment requirements for Key Personnel and ADOT's rights if it determines that any
28 such personnel are not devoting sufficient time to the prosecution and performance of
29 the Work required for the Project. Proposer may not make any changes in its Key
30 Personnel except as specified in ITP Section 2.10 or, after award, as specified in
31 Section 9.6 of the DBM Agreement.

32 **3.2.5.2 General Responsibilities of Key Personnel**

- 33 • Project Manager. See Section GP 110.08.2.1 of the Technical Provisions for a
34 description of the Project Manager's general responsibilities.
- 35 • Construction Manager. See Section GP 110.08.2.2 of the Technical Provisions
36 for a description of the Construction Manager's general responsibilities.
- 37 • Design Manager. See Section GP 110.08.2.3 of the Technical Provisions for a
38 description of the Design Manager's general responsibilities.
- 39 • Quality Manager. See Section GP 110.08.2.4 of the Technical Provisions for a
40 description of the Quality Manager's general responsibilities.

- 1 • Safety Manager. See Section GP 110.08.2.5 of the Technical Provisions for a
2 description of the Safety Manager's general responsibilities.
- 3 • Public Relations Officer. See Section GP 110.08.2.6 of the Technical Provisions
4 for a description of the Public Relations Officer's general responsibilities.
- 5 • ROW Acquisition Manager. See Section GP 110.08.2.7 of the Technical
6 Provisions for a description of the ROW Acquisition Manager's general
7 responsibilities.
- 8 • Utility Adjustment Coordinator. See Section GP 110.08.2.8 of the Technical
9 Provisions for a description of the Utility Adjustment Coordinator's general
10 responsibilities.
- 11 • Environmental Compliance Manager. See Section GP 110.08.2.9 of the
12 Technical Provisions for a description of the Environmental Compliance
13 Manager's general responsibilities.
- 14 • Maintenance Manager. See Section GP 110.08.2.10 of the Technical Provisions
15 for a description of the Maintenance Manager's general responsibilities.
- 16 • DBE/OJT Outreach and Compliance Manager. See Section GP 110.08.2.11 of
17 the Technical Provisions for a description of the DBE/OJT Outreach and
18 Compliance Manager's general responsibilities.

19 **3.2.6 Non-Collusion Affidavit**

20 The Technical Proposal shall include Form F, certifying that the Proposal is not the
21 result of and has not been influenced by collusion.

22 **3.2.7 DBE and OJT Requirements**

23 See ITP Section 1.10 for information on DBE and OJT requirements. See Sections
24 4.2.7.2 and 4.2.7.3 for inclusion of the following forms in the Preliminary DBE Utilization
25 Plan and the Preliminary OJT Utilization Plan.

26 The Proposal shall include a DBE Assurance & Project Goal Declaration (Form H-1)
27 confirming that Proposer will meet or exceed the DBE Goals or will make Good Faith
28 Efforts to do so.

29 The Proposal shall include a Record of Past DBE Performance (Form H-2) for each
30 Equity Member and Major Non-Equity Member that has acted as a prime consultant or
31 contractor on a federal-aid project. Use a separate Form H-2 for each entity.

32 The Proposal shall include a List of Currently Identified/Named Professional Services
33 DBE Subcontractors (Form H-3) for all Professional Services DBEs on the Project.

34 The Proposal shall include a List of Currently Identified/Named Construction DBE
35 Subcontractors (Form H-4) for all Construction Work DBEs already identified/named to
36 work on the Project.

37 The Proposal shall include a DBE Subcontractor Intent to Participate (Form H-5) for
38 each of the firms identified in Forms H-3 and H-4. Use a separate Form H-5 for each
39 entity.

1 The Proposal shall include an Identified Scope Items for Future Professional Services
2 DBE Participation (Form H-6).

3 The Proposal shall include an Identified Scope Items for Future Construction DBE
4 Participation (Form H-7).

5 The Proposal shall include a Bidder's List of All Subcontractors, Suppliers, Service
6 Providers and Manufacturers (Form H-8).

7 The Proposal shall include an OJT Assurance & Training Goal Declaration (Form I-1).

8 The Proposal shall include a Record of Past OJT Performance (Form I-2) for each
9 Equity Member and Major Non-Equity Member that has acted as a prime consultant or
10 contractor on a federal-aid project. Use a separate Form I-2 for each entity.

11 **3.2.8 Organizational Conflict of Interest Disclosure**

12 See ITP Section 7.0 for information on Organizational Conflicts of Interest. The
13 Proposal shall include a Conflict of Interest Disclosure Statement (Form J).

14 **3.2.9 Substantial Completion and Final Acceptance Deadlines**

15 Proposer shall include completed Baseline Substantial Completion and Baseline Final
16 Acceptance Dates in Form O.

17 **3.2.10 Certification Regarding Equal Employment Opportunity**

18 The Proposal shall include an Equal Employment Opportunity Certification (Form P) for
19 the Proposer, each Equity Member, each Major Non-Equity Member and known
20 Subcontractors. Use a separate Form P for each entity.

21 **3.2.11 Certification Regarding Use of Contract Funds for Lobbying**

22 The Price Proposal shall include Form Q to be executed by the Proposer, Equity
23 Members and Major Non-Equity Members.

24 **3.2.12 Certification Regarding Ineligible Contractors**

25 The Proposal shall include a Certification Regarding Ineligible Contractors (Form R).

26 **3.2.13 Certification Regarding Buy America**

27 The Proposal shall include a Buy America Certification (Form S).

28 **3.2.14 Evidence of Ability to Obtain and Maintain Insurance**

29 Proposer shall include written evidence from an insurance company, broker, agent or
30 advisor expressly indicating that Proposer (and Developer) will be able to obtain and
31 maintain the insurance types and amounts required by the DBM Agreement and can do
32 so under the terms, and subject to the conditions, specified in Article 11 and Exhibit 14
33 of the DBM Agreement. For guidance, see ITP Section 5.3.2(h).

34 **3.2.15 Stipend Agreement**

35 Proposer, at its option, may submit two sets of an executed Stipend Agreement in the
36 form of Exhibit 10. Proposers are advised that such sets must be submitted before

1 submission of the Technical Proposal, by no later than the date set forth in ITP Section
2 1.7, in order to be eligible for a stipend payment.

3 **SECTION 4 PROJECT DEVELOPMENT PLAN**

4 Proposer shall submit a Project Development Plan which shall consist of the following
5 components:

- 6 • Technical Approach (Section 4.1)
- 7 • Project Delivery Approach (Section 4.2)
- 8 • Preliminary Quality Management Plan (Section 4.3)

9 The submittal requirements for each component of the Project Development Plan are
10 described in the following sections.

11 **4.1 Technical Approach**

12 The Technical Approach section of the Technical Proposal shall describe Proposer's
13 approach to implementing the design, construction and maintenance Work and shall
14 include the elements set forth in this section.

15 The Proposer's Schematic Design as required in Section 4.1.1 shall be included as
16 Appendix 1-A to the Technical Proposal and shall include the following information with
17 respect to approved ATCs:

- 18 a) specifically state whether any approved ATCs are included in the Proposal, with
19 reference to the ATC identification number assigned by ADOT;
- 20 b) identify the location of each included ATC, using the ATC identification number;
21 and
- 22 c) describe how the ATC is used and provide cross-references to other elements of
23 the Proposal that are affected by the ATC.

24 In addition, Proposer shall provide, in an Appendix 1-B to the Technical Proposal,
25 copies of ATC approval letters issued by ADOT for each ATC (if any) incorporated into
26 the Proposal. Pricing information provided in the ATC approval letters, including ATC
27 adjustments of base scope price (if any) shall be redacted. The ATC approval letters
28 will not be counted toward the page limit for the Technical Proposal set forth in Section
29 2.0 to this Exhibit 2.

30 **4.1.1 Proposer's Schematic Design**

31 The Proposer's Technical Approach shall include plans/profile sheets or roll plots and
32 narrative descriptions identified in this Section 4.1.1 relevant to Proposer's proposed
33 approach.

34 Proposer's Technical Approach shall clearly identify the work to be completed by
35 Developer. Changes in alignments or other elements proposed by Proposer's Technical
36 Approach, to the extent they will require an evaluation for compliance with the NEPA
37 Approval and possibly re-evaluations and delays associated with such re-evaluations,
38 will be at Developer's risk.

1 Proposer's Technical Approach shall clearly identify accommodation for future SR 30
2 high capacity rail.

3 Items which do not apply to Proposer's proposed approach are to be specifically noted
4 as such. For all of the items not required, backup information is to be provided which
5 supports the non-applicability of the items.

6 **4.1.1.1 Bridges and Structures**

7 The Technical Approach shall provide preliminary plan/profile layout sheet(s) or roll
8 plots for each bridge and surface structure and a description of the bridges and surface
9 structures for the Project. The information shall include at least the following:

10 a) Layout sheets or roll plots for each bridge location indicating proposed
11 modifications to any bridge plans included as Reference Information Documents
12 with sufficient detail to indicate bridge type, foundation types, material,
13 appearance, width, controlling clearances, and span arrangement. Calculated
14 vertical clearances shall be shown in all profile views. Lane configurations and
15 clear zones of crossing roadways and railroads shall be clearly indicated, as
16 applicable. Include cross-sectional drawings of all proposed bridge types.
17 Preliminary bridge layout sheets or roll plots shall be at a scale of 1"=20' and
18 provide sufficient details to relay Proposer's intent for the planned structure.

19 b) Plans for surface structures (i.e., retaining and noise walls) indicating wall types
20 (including a typical section for each type), materials, appearance, proposed
21 locations and limits. Preliminary plan(s) shall be at a scale of 1"=200' and provide
22 sufficient details to relay Proposer's planned intent for the surface structure.

23 c) A narrative for bridges and surface structures that includes at least, the following:

24 (i) design life considerations;

25 (ii) a description of sequencing and phasing, including temporary
26 structures utilized during phasing of the Project;

27 (iii) Proposer's technical solutions to accomplish each of the following:

28 • minimize maintenance impacts on roadway operations;

29 • minimize negative impacts to existing facilities and infrastructure;
30 and

31 (iv) in addressing each item above, cite specific references to the
32 applicable Concept Plan(s) that supports the narrative.

33 **4.1.1.2 Roadway**

34 The Technical Approach shall provide preliminary roadway plans/profile sheets or roll
35 plots and a description of the roadway components for the Project. The information
36 shall include at least the following:

37 a) Preliminary plan and profile schematic sheets or roll plots for mainlines and HOV
38 lanes, frontage roads, interchanges and crossing roadways for the Proposer's
39 Schematic Design. Preliminary roadway plan and profile plan(s) shall be at a
40 scale of 1"=200' and provide sufficient details to relay Proposer's Schematic

1 Design for the Project, including: typical sections, general project roadway
2 information such as right of way and Project limits, design speeds and functional
3 classification(s). Proposed refinements in the horizontal and vertical geometric
4 configuration of the Schematic Design.

- 5 b) Roadway and interchange geometry to accommodate the Basic Configuration.
- 6 c) A description of Proposer's solution for pavement design.
- 7 d) A description of all existing roadways and structures to be closed, demolished,
8 left as is, or incorporated into the Project.
- 9 e) A description of Proposer's solution for minimizing future roadway costs for re-
10 surfacing and other capital improvements elements.
- 11 f) A description of Proposer's solution for minimizing impacts on roadway
12 operations from future roadway maintenance, resurfacing and improvement.
- 13 g) A description of the methodology to be used for life cycle cost analysis for the
14 Project over the duration of the DBM Agreement.

15 **4.1.2 Preliminary Transportation Management Plan**

16 The Technical Approach shall provide a description of the construction staging,
17 sequencing and transportation control to maintain traffic during the construction of the
18 Project. The information shall include at least the following:

- 19 a) A narrative description of the overall transportation management and control and
20 sequencing approach and what steps the Proposer intends to take to minimize
21 impacts on the environment, the traveling public, Stakeholders and communities,
22 while still providing acceptable construction performance. The narrative shall
23 include description of how Proposer's communication and public outreach
24 strategy will address work zone traffic control conditions.
- 25 b) A description of how the condition of adjacent roads will be maintained and the
26 extent to which access to other properties will be maintained throughout the
27 Project corridor during the construction including the intended measures to be
28 used to mitigate and minimize noise, vibration, light, dust, erosion/run-off and
29 local road damage due to construction activities. This section should cover how
30 the Proposer will engage adjacent agencies to coordinate impacts on
31 transportation operations, such as signal coordination and work zone
32 coordination.
- 33 c) A description of an approach to the construction staging and sequencing of the
34 Project, including the approach to phasing work between NTP2 and NTP3 Work.
- 35 d) A description of how Proposer will coordinate its construction work with other
36 projects that are expected to be under construction during the Work.
- 37 e) Proposer's Schematic Design shall indicate Proposer's preliminary maintenance
38 of traffic plans indicating the proposed construction staging, recycling, laydown
39 areas, disposal and maintenance locations (with approximate areas), which
40 demonstrates the methods to minimize disruptions to the traveling public and
41 impacts on the Stakeholders, and affected communities, businesses, and
42 residents. Preliminary maintenance of traffic plans shall be submitted in the

1 format indicated in Exhibit 6, at a scale of 1"=200' and provide sufficient details to
2 relay Proposer's intent.

3 **4.1.3 Other Project Design Components**

4 **4.1.3.1 Geotechnical and Earthwork**

5 The Proposal shall provide a description of the methods for taking into account the
6 surface and subsurface conditions of the Project in designing and constructing the
7 Project. The information shall include at least the following:

- 8 a) The proposed plan for geotechnical investigations, identifying the objectives,
9 scope of the work, and the information to be obtained, and the manner in which
10 Proposer will address property owners' concerns, compliance with environmental
11 commitments (including such commitments regarding discovery of unexpected
12 cultural resources after the Effective Date), and minimize intrusiveness of
13 investigations.
- 14 b) Conceptual instrumentation plan to monitor pore pressures, settlements and
15 stability, if any.
- 16 c) Approach to mass haul operations (including approach to processing, using or
17 placing materials removed from South Mountain within the mountain's vicinity)
18 and locations of potential borrow/waste sites and resulting impact on existing
19 roads.
- 20 d) Quality processes to be employed during construction of pavements for reduction
21 in long-term maintenance costs.
- 22 e) Preliminary pavement design report providing details of the proposed designs,
23 material types, roadway classifications, traffic loading and design life
24 considerations, in accordance with Section DR 419.3.4 of the Technical
25 Provisions.
- 26 f) Description of Proposer's approach surrounding:
 - 27 (i) blasting or ripping of materials within the South Mountain corridor to
28 achieve final roadway grades; mitigation and corrective measures to
29 address potential noise and vibration disturbance
 - 30 (ii) approach to address settlement and stability issues along the corridor; and
 - 31 (iii) mitigation and corrective measures to address potential groundwater
32 issues encountered along the corridor.

33 **4.1.3.2 Drainage**

34 The Proposal shall provide a description of the drainage for the Project. The
35 information shall include at least the following:

- 36 a) Description of the drainage system including identification of contributing
37 drainage areas, major crossings, mitigation of discharges and detention
38 requirements.
- 39 b) Description of Proposer's concept for providing temporary drainage or
40 construction sequencing of portions of the drainage network prior to completion
41 of entire drainage system.

- 1 c) Description of the approach for connecting to existing or proposed drainage
2 system(s), including identification of impacted owners and/or operators.
- 3 d) Description of Proposer's concept for minimizing maintenance of drainage
4 features.

5 **4.1.3.3 Utilities and Railroad Coordination**

6 The Proposal shall provide a description of the Utility Adjustments and railroad Work
7 required for the Project. The information shall include at least the following:

- 8 a) The proposed methods of locating known and unknown Utilities and railroad
9 horizontally and vertically that encroach upon the footprint of the Project.
- 10 b) The intended means of communication and planning of design and construction
11 to keep Utility Owners and railroad owners informed of the construction schedule,
12 the means of construction and changes that may affect their facilities.
- 13 c) The intended approach to relocation and permitting for railroad work and
14 relocation and material procurement for utilities (including high voltage power
15 line, high pressure gas line, and sewer force main). Address management of
16 potential schedule impacts due to material order lead time, 'Buy America'
17 requirements and maintaining operation of all Utilities to the greatest extent
18 practicable during construction.
- 19 d) The intended approach to managing identification of prior rights Utilities and
20 managing the decision-making process for cost responsibility.
- 21 e) The proposed methods of design and construction related to prior rights and no
22 prior rights Utility and railroad conflict identification, conflict mitigation measures,
23 and conflict resolution measures.
- 24 f) The proposed methods to facilitate cooperation from Utility Owners and railroad
25 owners, including, without limitation, the approach to negotiating utility and
26 railroad agreements and resolving betterment issues.
- 27 g) The proposed methods to continue coordination with Utility Owners throughout
28 the Maintenance Period, as necessary.

29 **4.1.3.4 Signage, Delineation, Pavement Markings, Signalization, ITS and Lighting**

30 The Proposal shall provide a description of signage, delineation, pavement markings,
31 signalization, ITS and lighting for the Project. The information shall include at least the
32 following:

- 33 a) A description of the approach for safety lighting at the ramps and high mast
34 lighting at the interchanges.
- 35 b) Approach for scheduling and phasing of the ITS and approach to maintaining ITS
36 on I-10.

37 **4.1.3.5 Preliminary Aesthetics and Landscape Master Plan**

38 Proposer shall prepare a Preliminary Aesthetics and Landscape Master Plan that
39 presents Proposer's overall approach and concept for the aesthetics and landscape for
40 the Project. The Preliminary Aesthetics and Landscape Master Plan must include, at a
41 minimum, the following:

- 1 a) Design Requirements.
- 2 • A report describing the design approach, standards, and aesthetics and
- 3 landscape components.
- 4 • Describe how the aesthetic rustication and landscape concepts of the
- 5 Landscape Architecture and Aesthetics Design Concept Report (LAADCR)
- 6 will be incorporated into the overall design.
- 7 b) Construction Requirements.
- 8 • Describe how Proposer intends to construct the aesthetic treatments and
- 9 install plants
- 10 c) Appendix
- 11 • Rustication plan sheets or roll plots that portray in elevations, sections, and
- 12 details how the rustication patterns for each character area will look.
- 13 • Planting plan sheets or roll plots that show plant layouts for each character
- 14 area at a typical interchange and a typical roadside section. The planting plan
- 15 sheets or roll plots must identify through symbols the plant species used and
- 16 how they will typically be arranged.

17 **4.2 Project Delivery Approach**

18 The Project Delivery Approach section of the Technical Proposal shall describe

19 Proposer's approach and understanding of the various management aspects of the

20 Project and shall include the elements set forth in this section.

21 **4.2.1 Preliminary Project Management Plan – Project Administration Chapter**

22 The Preliminary Project Management Plan – Project Administration Chapter shall set

23 out Proposer's management approach to design, construction, traffic management,

24 maintenance, handback upon completion of the DBM Agreement, documentation,

25 testing and auditing/reporting for the Project, risk, community outreach and

26 organizational structure. The minimum information to be provided within the Preliminary

27 Project Management Plan – Project Administration Chapter is detailed in this Section

28 4.2.1.

29 The Preliminary Project Management Plan – Project Administration Chapter shall

30 describe Proposer's overall Project management plan and approach to the work

31 (including design, construction, and maintenance), including at least the following:

- 32 a) A description of the methods to be used to assure necessary communication and
- 33 documentation within Proposer's team, including communication among the
- 34 Subcontractor organizations and management personnel.
- 35 b) A description of how Proposer intends to:
- 36 (i) provide the experienced personnel, facilities and equipment, and to
- 37 integrate such resources, to complete each aspect of the Project;
- 38 (ii) control and coordinate the various Subcontractors;
- 39 (iii) interface with ADOT, its consultants and relevant federal, State and local
- 40 agencies;

- 1 (iv) interface with applicable railroads and Utility Owners; and
2 (v) comply with applicable Laws.
- 3 c) An organization chart outlining the basic structure of Proposer's Project
4 organization (including the design, construction and maintenance sub-
5 organizations) and a description of the roles, responsibilities, interrelation and
6 work to be accomplished by each member of the management team and each
7 sub-organization, including identified Subcontractors and Suppliers (at all tiers).
- 8 d) Information describing how each of the Key Personnel will fit into the
9 organization, including a description of the function and responsibility of each
10 Key Personnel relative to the Project.
- 11 e) A detailed description of how the team members will work together to provide a
12 unified design, construction, maintenance, and quality approach to all elements
13 of the work in order to manage and promote life-cycle efficiency.
- 14 f) A description of the team decision making process, including how internal
15 disputes between team members will be resolved.
- 16 g) All major training program(s) to ensure that continuous improvement practices
17 are being implemented.
- 18 h) Information regarding the current and projected workload and backlog of the
19 Proposer team (including all Equity Members and Major Non-Equity Members)
20 including the Proposer's or team member's plan for allocating its resources and
21 personnel among the projects.
- 22 i) Description of the approach to identification, management, mitigation, and
23 allocation of Project-specific risks, whether borne by ADOT or the Developer or
24 shared. This shall include a description of the Proposer's proposed procedures
25 and tools to conduct a risk sensitivity analysis, and a risk matrix which shall
26 identify the following at a minimum:
- 27 (i) Proposer's description of the significant risk categories during the design,
28 construction and maintenance of the Project.
- 29 (ii) Proposer's identification of the potential consequences of the identified risks.
- 30 (iii) Proposer's estimation of the probability/likelihood of the risks occurring.
- 31 (iv) For each identified risk, a description of the Proposer's risk-mitigation
32 strategies to eliminate or reduce the risk.
- 33 j) A description of Proposer's plan and management approach for performing
34 design on the Project, including at least the following:
- 35 (i) how Proposer intends to manage the development and coordination of
36 design, including issues such as design of connecting projects, right of
37 way, survey, environmental permitting, utilities, railroad, community
38 relations and safety issues;
- 39 (ii) the proposed approach for delivering the design for the Project, including
40 where the designers will be located, how designs are to be developed by
41 different firms, how offices will be integrated and work coordinated to
42 ensure consistency and quality; and

- 1 (iii) how the design personnel will interface with the construction and
2 maintenance personnel to achieve a quality constructed Project that
3 minimizes long-term maintenance.
- 4 k) A description of Proposer's plan to manage permitting and third-party
5 coordination and approvals.
- 6 l) A description of Proposer's plan and management approach and strategies for
7 public information and communication, including at least the following:
- 8 (i) approach to support ADOT in positively implementing and managing
9 community relations during the design, construction and maintenance
10 stages of the Project;
- 11 (ii) approach to Project marketing and advertising;
- 12 (iii) approach and strategies for adjustment to construction and maintenance
13 activities in response to community and Stakeholder concerns; and
- 14 (iv) description of Proposer's approach to public information activities and
15 communication strategies, including identification of personnel for such
16 effort and how Proposer will manage interaction with ADOT, the
17 communities, and other Stakeholders, including FHWA and the GRIC.

18 **4.2.2 Project Schedule and Cost Control Management**

19 The Project Delivery Approach shall provide a description of Proposer's plan and
20 management approach for schedule and cost control on the Project, including at least
21 the following:

- 22 a) A Preliminary Project Baseline Schedule, prepared in accordance with the
23 requirements for the Project Baseline Schedule set forth in Section GP
24 110.06.2.6 of the Technical Provisions, and narrative for all D&C Work. The
25 narrative shall describe the proposed execution of the Work for the term of the
26 DBM Agreement, and the approach for preparing, controlling and updating the
27 Project Baseline Schedule, for calculating progress performance, and preparing
28 Draw Requests on a monthly basis. The Preliminary Project Baseline Schedule
29 shall:
- 30 (i) be included as Appendix 1-C to the Technical Proposal; and
- 31 (ii) contain all major D&C Work activities or milestones to a work breakdown
32 structure (WBS) level sufficient to demonstrate activities with a duration no
33 longer than 60 days; and
- 34 (iii) indicate applicable constraints; and
- 35 (iv) include a date for Substantial Completion of the Project (no later than
36 1350 days from issuance of NTP 1) and a date for Final Acceptance of the
37 Project (no later than 180 calendar days after Substantial Completion)
38 identical to those Proposer states in Form O as the Proposal Commitment
39 Date for Substantial Completion and the Proposal Commitment Date for
40 Final Acceptance.
- 41 b) Describe the proposed Project schedule methodology and cost control approach
42 and include at least the following:

- 1 (i) a description of the system used for preparing and updating the Project
2 schedule;
- 3 (ii) a description of how the Proposer will integrate schedule and cost control
4 approaches.
- 5 (iii) a description of the proposed plan to integrate Subcontractor activities into
6 Proposer's scheduling and reporting system;
- 7 (iv) a description of the proposed approach for calculating progress
8 performance on a monthly basis and preparing payment requests; and
- 9 (v) a description of how Proposer will approach re-scheduling of its work to
10 achieve schedule recovery objectives and how these objectives will be
11 enforced with its work force and Subcontractors.
- 12 (vi) Approach to identification of constraints that are consistent with the
13 Contract Documents.

14 Proposer's Preliminary Project Baseline Schedule submission shall not limit, modify or
15 alter ADOT's ability to review and approve the Preliminary Project Baseline Schedule,
16 and selection of a Proposer shall not be deemed to be acceptance or approval of
17 Proposer's Preliminary Project Baseline Schedule.

18 **4.2.3 Preliminary ROW Activity Plan**

19 The Project Delivery Approach shall include a Preliminary ROW Activity Plan describing
20 how Proposer will meet the right-of-way performance requirements and perform right-of-
21 way services for the Project. The information shall include at least the following:

- 22 a) Proposer's ROW organizational chart including the names of the Subcontractors
23 to be used.
- 24 b) A description of the approach to the ROW activities, to include the goals and
25 milestones established for Project ROW acquisition, ROW Plans, exhibits and
26 legal descriptions, relocation assistance, appraisals, appraisal review, and
27 clearance / demolition of the improvements from the Project ROW (except for
28 parcels where ADOT will retain responsibility for demolition);
- 29 c) The approach describing how the acquisition of right-of-way and any necessary
30 relocation services will be managed by Proposer in conjunction with ADOT, local
31 officials and the Office of the Attorney General.
- 32 d) A description of the quality control procedures and quality review standards for
33 the acquisition of Project ROW that Proposer will employ to assure that all
34 property owners' rights under the Uniform Relocation and Real Property
35 Acquisition Policies Act of 1970, as amended, are being satisfied, including the
36 safeguards and policies Proposer will implement to ensure that no coercive
37 actions, as described in 49 CFR 24.102(h), will result from advancing a portion of
38 right-of-way to the construction stage, and that no other actions will occur that
39 could adversely affect the right-of-way acquisition process.
- 40 e) A description of the acquisition and relocation process that will maintain the
41 Project schedule but be sensitive to the needs and concerns of property owners,
42 lessees, licensees and other occupants.

- 1 f) A description of a typical parcel acquisition, reflecting timelines associated with:
 - 2 (i) survey;
 - 3 (ii) appraisal;
 - 4 (iii) acquisition;
 - 5 (iv) relocation; and
 - 6 (v) acquisition by eminent domain.
- 7 g) A description of how this timeline will be integrated into the Preliminary Project
- 8 Baseline Schedule to avoid delays.
- 9 h) A description of the Proposer's ROW approach as it relates to Proposer's specific
- 10 Project design.

11 **4.2.4 Preliminary Maintenance Management Plan**

12 The Project Delivery Approach shall include a Preliminary Maintenance Management
13 Plan describing how Proposer will meet the performance requirements set forth in
14 Article 8 of the DBM Agreement and in Section D of the Technical Provisions. For the
15 Preliminary Maintenance Management Plan, the Proposal shall address at least the
16 following:

- 17 a) Maintenance management tools (such as communications, computers, software
18 and equipment).
- 19 b) The plan and approach to annual Routine Maintenance and reporting, and how
20 they will be used to manage the Project.
- 21 c) Inspection and testing of Project items (including pavements, shoulders, bridges,
22 sound and retaining walls, embankments and cut slopes) and the identification
23 and classification of defects and inspection failures.
- 24 d) How defects or faults in any aspect of the Project's infrastructure shall be
25 classified and rectified within appropriate time limits.
- 26 e) The proposed program for the planning, implementation and completion of future
27 Capital Asset Replacement Work during the term of the DBM Agreement. The
28 information shall describe the approach to programming of works and costing
29 and ensuring that maintenance transition requirements from construction to
30 maintenance of the capital assets will be met.
- 31 f) The plan and approach to transitioning and phasing from construction to Routine
32 Maintenance activities.
- 33 g) The plan and approach for transfer of Routine Maintenance and Capital Asset
34 Replacement Work responsibility for the Project to ADOT at the expiration or
35 termination of the DBM Agreement, including a preliminary list of specialized
36 Routine Maintenance equipment that will be turned over to ADOT.
- 37 h) The plans, policies and procedures for ensuring the health and safety of
38 personnel involved in the Project and the general public affected by the Project
39 for the term of the DBM Agreement.

- 1 i) The approach to traffic control and operations during Routine Maintenance and
2 Capital Asset Replacement Work activities, including lane closures and other
3 traffic restrictions.

4 **4.2.5 Preliminary Environmental Management Plan**

5 The Project Delivery Approach shall include a Preliminary Environmental Management
6 Plan describing Proposer's planned approach to complying with the environmental
7 requirements of the Project and any environmental issues that may arise. The
8 information shall include at least the following:

- 9 a) A description of Proposer's plan and management approach to environmental
10 compliance, employee training, permitting and impact mitigation, including at
11 least the following:
- 12 (i) applicable laws, rules and regulations;
 - 13 (ii) methodology Proposer will use to ensure planning commitments are
14 integrated into design, construction and maintenance of the Project; and
 - 15 (iii) approach to Stakeholder and public involvement in relation to the
16 Environmental Management Plan.
- 17 b) A list of environmental permits, permit amendments and other approvals,
18 whether state, federal or local, that will or may be required, together with the
19 name of the issuing agency and a plan for obtaining required permits and permit
20 amendments in a timely manner.
- 21 c) A description of the measures that will be undertaken to ensure compliance with
22 environmental permits and approvals and approvals relating to cultural
23 resources.
- 24 d) A description of the environmental issues anticipated to be encountered on the
25 Project and how design and construction will address the anticipated impacts and
26 be sensitive to the environment.
- 27 e) Approach to hazardous materials management, including the management of
28 lead paint and asbestos in demolition elements of the Work.

29 **4.2.6 Preliminary Safety Management Plan**

30 The Project Delivery Approach shall include a Preliminary Safety Management Plan
31 describing the Proposer's approach to safety during the construction phase of the
32 Project, including at least the following:

- 33 a) A general outline of Proposer's Safety Management Plan for the Project.
34 b) A description of Proposer's implementation strategy to meet safety commitments
35 and requirements during construction.

36 **4.2.7 DBE / OJT Outreach and Compliance Plan**

37 **4.2.7.1 DBE Declaration**

38 Each Proposer shall submit with its Technical Proposal, without revision, a signed Form
39 H-1, DBE Assurance & Project Goal Declaration, acknowledging the Proposer's
40 commitment to meet or exceed the DBE Goals or exercise aggressive Good Faith

1 Efforts to do so, in accordance with the DBE Special Provisions and Title 49 CFR Part
2 26. Failure to provide this declaration, without revision, shall render a Proposal non-
3 responsive.

4 **4.2.7.2 Preliminary DBE Utilization Plan**

5 Each Proposer shall include in its Technical Proposal a Preliminary DBE Utilization
6 Plan. The Preliminary DBE Utilization Plan shall not exceed 12 pages in length, plus
7 the required Forms to be included with the Plan.

8 At a minimum, the Preliminary DBE Utilization Plan shall include the following
9 components:

- 10 a) Overview of the Proposer's understanding of the DBE program and its
11 commitment to meeting or using Good Faith Efforts to meet the DBE Goals and
12 all other DBE requirements. Also include the Proposer's overall DBE
13 implementation strategy and its history/record of DBE performance on past
14 federally-funded contracts. Include a completed Form H-2, Record of Past DBE
15 Performance, for each of the Equity Members and Major Non-Equity Members on
16 the Proposer's team that that has acted as a prime consultant or contractor on a
17 federal-aid project.
- 18 b) Description of DBE team/staff who will be working on the Project. Include name,
19 experience and responsibilities of DBE compliance team members (including the
20 DBE/OJT Outreach and Compliance Manager included in the SOQ) responsible
21 for implementing and complying with the Proposer's DBE Utilization Plan and all
22 DBE regulations. ADOT plans to convene an interdisciplinary Compliance
23 Oversight Committee, which will include ADOT's general engineering consultant
24 for the Project, FHWA, and ADOT's Business Engagement & Compliance Office,
25 to oversee DBE/OJT/EEO compliance on the Project (see Section 13.02 of the
26 DBE Special Provisions). Include a description in the Preliminary DBE Utilization
27 Plan of how the Proposer's DBE/OJT Outreach and Compliance Manager and
28 his/her staff plans to work with ADOT's Compliance Oversight Committee.
- 29 c) Description of types of proactive DBE and small business bid-specific marketing,
30 recruitment, outreach and community engagement efforts made by the Proposer
31 prior to and during the RFP process to secure DBEs for the Project. Include a
32 completed Form H-3, List of Currently Identified/Named DBE Subcontractors, a
33 completed Form H-4, List of Currently Identified/Named Construction DBE
34 Subcontractors, and a completed Form H-5, DBE Subcontractor Intent to
35 Participate, for all Professional Services, Construction and Capital Asset
36 Replacement Work DBEs already secured to be a part of the Proposer's team.
- 37 d) Completed Bidder's List Form-H-8 with the name, contact information, and other
38 required information listed on the form for every firm quoting, bidding or expressing
39 an interest in providing subcontract services for the Project. Furthermore, all
40 Proposers and their Equity Member and Major Non-Equity Member must be
41 registered as a Vendor in the Arizona Unified Transportation Registration and
42 Certification System (AZ UTRACS) web portal; a centralized database for
43 companies that are "ready, willing and able" to do business with the ADOT. Firms
44 can register at <https://adot.dbesystem.com/>. Include AZ UTRACS Vendor

1 Registration Number for Developer, Equity Members and Major Non-Equity
2 Members in this section of Preliminary DBE Utilization Plan.

3 e) Overview of types of proactive DBE and small business bid-specific marketing,
4 recruitment, outreach and community engagement efforts that will be
5 implemented throughout the Project design, construction and Capital Asset
6 Replacement Work in order to include DBEs and small businesses on the
7 Project. Include process for timely communications, outreach methods that will
8 be used, and a process for keeping track of potential DBEs, small businesses
9 and other Subcontractors on the Project. Include proposed innovative methods
10 for (a) involving new and emerging DBEs, and (b) identifying firms that might
11 potentially be certified as DBEs and assisting them to become DBE-certified and
12 be involved in the Project. Discuss how these efforts will flow through tiers of
13 Subcontractors on the Project.

14 f) Description/itemization of economically-feasible work units (smaller tasks or
15 quantities) of professional services, construction work and Capital Asset
16 Replacement Work items on the Project that can be subcontracted to facilitate
17 DBE participation that have not yet been assigned. Related to this description,
18 Proposer shall include a Forms H-6 and H-7, Identified Scope Items for Future
19 DBE Participation, regarding additional scope of work items that can be
20 unbundled by the Proposer for future participation by DBEs, for which DBEs have
21 not yet been named/assigned (excluding DBE participation listed on Form H-3).
22 Proposer also shall include a brief description of a plan to secure DBE firms for
23 those scopes of services identified in these Forms. Include efforts to encourage
24 DBE and small business teaming/partnering on large work items packages.

25 g) Overview of measures that the Proposer will undertake throughout the term of
26 the DBM Agreement to help achieve the DBE Goals, including training
27 workshops, technical and financial assistance, support services, mentor/protégé
28 relationships, recruiting and encouraging potential DBEs to get certified, etc. For
29 reference, see 49 CFR Part 26, Appendix A.

30 **4.2.7.3 DBE Good Faith Efforts Documentation**

31 If Proposer indicates in Form H-1 a reasonable belief that any of the DBE Goals cannot
32 be achieved through aggressive Good Faith Efforts, Proposer must submit additional
33 documentation of its Good Faith Efforts undertaken prior to the Proposal Due Date in
34 accordance with the DBE Special Provisions and 49 CFR Part 26, Appendix A. This
35 documentation shall not exceed four pages in length.

36 **4.2.7.4 Bidder's List – AZUTRACS Vendor Registration**

37 Each Proposer shall include in its Technical Proposal a list of the names and required
38 information for all subcontractors, suppliers, service providers and manufacturers that
39 submitted bids, proposals or quotes to the Proposer or expressed an interest in working
40 for the Proposer on the Project. Submit such information on Form H-8, Bidders' List of
41 All Subcontractors, Suppliers, Service Providers and Manufacturers. The form must be
42 complete and must include all the required information regardless of the Proposer's
43 intentions to use the subcontractors, suppliers, service providers and manufacturers.
44 Proposer and each Equity Member and Major Non-Equity Member to be involved in
45 design or construction of the Project must be registered as a vendor in AZUTRACS and

1 provide an AZUTRACS Vendor Number on the Bidder's List form. To determine if your
2 firm is registered as a vendor, search by firm name at:
3 <https://adot.dbesystem.com/FrontEnd/VendorSearchRegistry.asp?TN=adot&XID=5475>.
4 If the firm is listed at the bottom of the page in the Search Results, it is registered as a
5 vendor. If it is not listed, the firm shall register by going to this website:
6 <https://adot.dbesystem.com/FrontEnd/StartRegistry.asp?TN=adot&XID=6761>.
7 Visit the AZ UTRACS website at: <https://adot.dbesystem.com> for further information or
8 contact the Procurement Manager.

9 **4.2.7.5 OJT Declaration**

10 Each Proposer shall submit with its Technical Proposal, without revision, a signed Form
11 I-1, OJT Assurance & Training Goal Declaration, acknowledging the Proposer's
12 commitment to meet or exceed the OJT Goals or exercise aggressive Good Faith
13 Efforts to do so, in accordance with the OJT Special Provisions and 23 CFR Part 230.
14 Failure to provide this declaration, without revision, shall render a Proposal non-
15 responsive.

16 **4.2.7.6 Preliminary OJT Utilization Plan**

17 Each Proposer shall include in its Technical Proposal a Preliminary OJT Utilization Plan
18 documenting actions it will take to obtain sufficient participation by women, minority,
19 veteran and disadvantaged individuals to meet the OJT Goals throughout the
20 Construction Work and to meet related OJT and Equal Employment Opportunity (EEO)
21 requirements. The Preliminary OJT Utilization Plan shall not exceed five pages in
22 length, plus the required Forms to be included with the Plan.

23 The Preliminary OJT Utilization Plan must address how the Proposer plans to recruit,
24 manage, retain, track, provide oversight and monitoring, and report trainee progress
25 and completion to ADOT for the Project. At a minimum, the Preliminary OJT Utilization
26 Plan must include the following components:

- 27 a) Overview of Proposer's understanding of the OJT requirements and its
28 commitment to meeting or using Good Faith Efforts to meet the OJT Goals and
29 all other OJT requirements. Also include the Proposer's overall OJT
30 implementation strategy and its history/record of OJT performance on past
31 federally-funded contracts. Include a completed Form I-2, Record of Past OJT
32 Performance for each of the Equity Members and Major Non-Equity Members
33 that has acted as a prime consultant or contractor on a federal-aid project.
- 34 b) Description of OJT team/staff who will be working on the Project. Include name,
35 experience and responsibilities of the OJT compliance team members (including
36 the DBE/OJT Outreach and Compliance Manager included in the SOQ)
37 responsible for implementing and complying with the Proposer's OJT Utilization
38 Plan and all OJT regulations. Include a description in the Preliminary OJT
39 Utilization Plan of how the Proposer's DBE/OJT Outreach and Compliance
40 Manager and his/her staff plans to work with ADOT's Compliance Oversight
41 Committee.
- 42 c) Description of types of proactive OJT marketing, recruitment, outreach and
43 community engagement efforts that have been made prior to and during the RFP

1 process and will be made by the Proposer throughout the period up to
2 Substantial Completion to secure women, minority, veteran and disadvantaged
3 trainees for the Project. Include information about the Proposer's OJT Trainee
4 screening, hiring and processes to retain trainees.

5 d) Description of Proposer's preliminary OJT program to be used to train and
6 educate women, minority, veteran and disadvantaged individuals in various
7 construction related crafts during each phase/segment of the Construction Work
8 that Proposer identifies pursuant to Section 4.2.2 of this Exhibit 2. Include efforts
9 to recruit Native American workers, as this Project is near an Indian reservation.

10 e) An estimated OJT participation schedule for each phase/segment of the
11 Construction Work, and a brief description of processes and procedures that the
12 Proposer will use to document changes/adjustments of the OJT participation
13 schedule to ensure achievement of the OJT Goals. Include time intervals at
14 which these processes and procedures will be employed.

15 **4.3 Preliminary Quality Management Plan**

16 The Preliminary Quality Management Plan section of the Technical Proposal shall
17 describe Proposer's approach to quality management during all stages of the Project,
18 and shall include the elements set forth in this section.

19 **4.3.1 General Requirements**

20 The Preliminary Quality Management Plan shall describe Proposer's planned
21 organization, roles and responsibilities of the quality staff. The information shall include
22 at least the following:

23 a) A description of the proposed Professional Services, construction and
24 maintenance quality program organization, including the name and resume of
25 Key Personnel responsible for quality management. Also, provide qualifications
26 of IQF and resume of Construction Independent Quality Manager.

27 b) An organization chart showing the quality management structure, along with a
28 staffing plan by position title.

29 c) A description of Proposer's planned audit processes and procedures for
30 quality assurance and quality control during Professional Services, construction
31 and maintenance phases.

32 d) A description of how the quality management staff will function independently so
33 that such individuals will have the authority to effect changes in the event of
34 Developer's failure to comply with the Contract Documents.

35 e) A description of how the Professional Services quality, construction quality and
36 maintenance quality functions will interface.

37 **4.3.2 Professional Services Quality Management Approach**

38 The Preliminary Quality Management Plan shall describe Proposer's understanding and
39 approach to Professional Services quality management for the Project as well as
40 methodology used to minimize quality issues and re-work on the Project. The
41 description of the Proposer's design quality management approach shall include at least
42 the following:

- 1 a) A description of Proposer's planned quality assurance and quality control
2 procedures for Professional Services.
- 3 b) A description of both the formal and the informal process for Professional
4 Services work products.
- 5 c) A description of quality interface processes among the Professional Services
6 quality management personnel on the Project.
- 7 d) A description of how the Professional Services quality management team will
8 coordinate and communicate with ADOT during the D&C Period, and interface
9 with ADOT Professional Services oversight procedures.
- 10 e) Approach to documenting and curing Professional Services deficiencies and
11 noncompliance issues thereby ensuring that repeat mistakes are avoided.

12 **4.3.3 Construction Quality Management Approach**

13 The Preliminary Quality Management Plan shall describe Proposer's understanding and
14 approach to construction quality management for the Project as well as processes used
15 to minimize non-conformance issues during construction. The description of the
16 Proposer's construction quality management approach shall include at least the
17 following:

- 18 a) A description of Proposer's planned quality assurance and quality control
19 procedures for construction.
- 20 b) The approach to quality acceptance testing, documentation and inspection during
21 construction activities.
- 22 c) Proposed quality management documentation procedures during construction.
- 23 d) A description of how the construction quality management team will coordinate
24 and communicate with ADOT during the construction, and interface with ADOT
25 construction oversight procedures.
- 26 e) Approach to documenting and curing construction deficiencies and
27 noncompliance issues thereby ensuring that repeat mistakes are avoided.

28 **4.3.4 Maintenance Quality Management Approach**

29 The Preliminary Quality Management Plan shall describe Proposer's understanding and
30 approach to maintenance quality management for the Project as well as processes
31 used to minimize traffic disruptions on the Project. The description of the Proposer's
32 maintenance quality management approach shall include at least the following:

- 33 a) A description of Proposer's planned quality assurance and quality control
34 procedures for maintenance.
- 35 b) The approach to acceptance testing, documentation and inspection of
36 construction during the Maintenance during Period;
- 37 c) proposed quality management documentation procedures of construction during
38 the Maintenance Period.

- 1 d) A description of how the quality management team will coordinate and
- 2 communicate with ADOT regarding construction during the Maintenance Period,
- 3 and interface with ADOT construction oversight procedures.
- 4 e) Approach to documenting and curing maintenance deficiencies and issues
- 5 thereby minimizing traffic delays and interruptions.

2 FINANCIAL PROPOSAL INSTRUCTIONS

3
4 **SECTION 1 GENERAL INSTRUCTIONS**

5 This Exhibit 3 describes the submission format for Financial Proposals and outlines the
6 required information that will comprise the Financial Proposal.

7 Proposer shall submit the information required by this Exhibit 3 in the organization and
8 format specified herein. The Financial Proposal shall be organized in the order listed in
9 Exhibit 6, and shall be clearly indexed. Each component of the Financial Proposal shall
10 be clearly titled and identified.

11 **1.1 Format of Financial Proposal**

12 All financial information provided in the Financial Proposal shall be in U.S. Dollar
13 currency only.

14 If there are any discrepancies between the hard copy and electronic copy of any
15 quantitative information provided in the Financial Proposal, the hard copy version will
16 prevail. If there are any differences between individual line amounts and totals, the
17 individual line amounts will prevail.

18 **1.2 Contents of Financial Proposal**

19 Proposer shall not amend the order or change the contents of the checklist except to
20 provide the required cross reference to its Proposal.

21 If a guaranty is required, then the Financial Proposal shall include (in addition to the
22 Financial Information listed in Section 2): (a) an irrevocable letter signed by the
23 Guarantor in the form of Form T committing to provide a guaranty in the form of Exhibit
24 11-1 or Exhibit 11-2 to the DBM Agreement, as applicable, concurrently with execution
25 and delivery of the Contract Documents by Proposer, (b) evidence of authorization of
26 the signatory to that letter, (c) Form B, Part 1 for the Guarantor, (d) financial information
27 for the Guarantor described in Section 2, and (e) such other information concerning the
28 Guarantor as ADOT may request.

29 **SECTION 2 FINANCIAL INFORMATION**

30 Proposers shall clearly identify any differences between the financial information
31 submitted in the Proposal and the information submitted in the SOQ.

32 **2.1 Surety Letter**

33 The Financial Proposal shall include a letter from a surety/insurance company indicating
34 that it has reviewed the Contract Documents, and is prepared to issue the D&C
35 Performance Bond and D&C Payment Bond in the form and amount required by the
36 ITP. If the Developer or Lead Subcontractor, as applicable, is a joint venture,
37 partnership, limited liability company or other association, separate letters for one or

1 more of the individual Equity Members or joint venturer, partner or member of the Lead
2 Subcontractor, as applicable, are acceptable, as is a single letter covering all Equity
3 Members, joint venturers, partners or members. If more than one letter is provided,
4 each letter shall set forth the portion of the bond amount the surety/insurance company
5 will be issuing.

6 Each surety/insurance company providing such letter must be (a) licensed and
7 authorized to do business in the State, (b) listed on the U.S. Department of the
8 Treasury's "Listing and Approved Sureties" (found at
9 www.fms.treas.gov/c570/c570.html), and (c) rated as provided in ITP Section 6.1.2(j).

10 The letter must indicate the relevant rating of the surety/insurance company. The letter
11 must specifically state that the surety/insurance company is a licensed and admitted
12 surety or insurer in the State (approved by the Arizona Department of Insurance), is
13 listed on the U.S. Department of the Treasury's "Listing and Approved Sureties," has
14 read the RFP (including the ITP) and any addenda, and has evaluated the backlog,
15 work in progress, recently awarded contracts and conditionally awarded contracts as of
16 the date of the letter for the entity for which it will provide the bonds in determining its
17 willingness to issue the D&C Performance Bond and D&C Payment Bond. In instances
18 where the response to this Section 2.1 contains descriptions of proposed or anticipated
19 changes in the financial condition of the Proposer, or any other entity for which financial
20 information is submitted as required hereby for the next reporting period, the
21 surety/insurance company must certify in the letter that its analysis specifically
22 incorporates a review of the factors surrounding such changes.

23 **2.2 Financial Statements**

24 The Financial Proposal shall include the following information for Proposer, all Equity
25 Members, all Major Non-Equity Members, and any parent or sister companies if such
26 information was required to satisfy the requirements of the RFQ:

- 27 • Audited financial statements (fiscal year end and quarterly) for all periods
28 subsequent to those included in the SOQ (or if not included in the SOQ, for
29 2012, 2013 and 2014.
- 30 • In addition, interim unaudited financial statements for the period since the
31 most recent completed fiscal year or quarter.
- 32 • For publicly held companies, most recent SEC 10-K and 10-Q reports and
33 any 8-Ks filed since the date Proposer submitted its SOQ.

34 If a Guaranty will be necessary for Proposer to satisfy the net worth
35 financial responsibility requirements in Section 10.4 of the DBM Agreement, the
36 Proposer shall also submit financial statements for each Guarantor that will execute a
37 Guaranty in satisfaction of such requirements. Such financial statements shall cover
38 the same periods as indicated above.

39 To assure confidentiality, each entity's financial statements may be provided to ADOT in
40 sealed envelopes. Each sealed envelope shall be labeled with the name of the entity
41 and the entity's role (i.e. Equity Member, Lead Contractor, etc.)

42 The financial statements must include:

- 1 • Opinion Letter (Auditor’s Report);
- 2 • Balance Sheet;
- 3 • Income Statement;
- 4 • Statement of Changes in Cash Flow; and
- 5 • Footnotes.

6 In addition, financial statements must meet the following requirements:

7 a) GAAP

8 Financial statements must be prepared in accordance with U.S. Generally Accepted
9 Accounting Principles (U.S. GAAP) or International Financial Reporting Standards
10 (IFRS). If financial statements are prepared in accordance with principles other than
11 U.S. GAAP or IFRS, a letter must be provided from a certified public accountant
12 discussing the areas of the financial statements that would be affected by a conversion
13 to U.S. GAAP or IFRS. A restatement of the financial information in accordance with
14 U.S. GAAP or IFRS is not required.

15 b) U.S. Dollars

16 Financial statements shall be provided in U.S. dollars, if available. If financial
17 statements are not available in U.S. dollars, the Proposer must include summaries of
18 the income statements, statements of cash flow, and balance sheets for the applicable
19 time periods converted to U.S. dollars by a certified public accountant.

20 c) Audited

21 Financial statements must be audited by an independent party qualified to render audit
22 opinions (e.g., a certified public accountant). If audited financials are not available for an
23 entity, the Proposal shall include unaudited financial statements for such entity, certified
24 as true, correct and accurate by the chief executive officer, chief financial officer, or
25 treasurer (or by such equivalent position or role) of the entity.

26 d) English

27 Financial statement information must be prepared in English. If audited financial
28 statements are prepared in a language other than English, translations of all financial
29 statement information must be provided with the original financial statement information.

30 e) Newly Formed Entity

31 If the Proposer is a newly formed entity (formed within two years before the SOQ
32 Due Date) and does not have independent financial statements, financial statements
33 for the Equity Members shall be provided (and the Proposer shall expressly state
34 that the Proposer is a newly formed entity and does not have independent financial
35 statements).

36 f) SEC Filings

37 If the Proposer or any other entity for whom financial information is submitted in the
38 Financial Proposal files reports with the Securities and Exchange Commission, then

1 such financial statements shall be provided through a copy of their annual report on
2 Form 10-K. For all subsequent quarters, provide a copy of any report filed on Form 10-
3 Q or Form 8-K which has been filed since the latest filed 10-K.

4 g) Off-Balance Sheet Liabilities

5 A letter from the certified public accountant, chief financial officer, treasurer or certified
6 public accountant for each entity for which financial information is submitted, identifying
7 all material off balance sheet liabilities

8 **2.3 Credit Ratings**

9 Proposer shall provide: (a) a list identifying each entity for which financial statements
10 are provided; (b) a statement indicating whether each entity has a credit rating; and (c)
11 for each entity with a rating, the current rating.

12 **2.4 Material Changes in Financial Condition**

13 Proposer shall provide information regarding any material changes in financial condition
14 for the Proposer, each Equity Member and each Major Non-Equity Member, any parent
15 or sister company of the Lead Contractor or Lead Maintenance Firm if such information
16 was required to satisfy the requirements of the RFQ and, if applicable, each Guarantor
17 for the most recent fiscal year and anticipated for the next reporting period. In each
18 case, if any of the foregoing entities is a consortium, partnership, or any other form of a
19 joint venture, provide this information for all such members. If no material change has
20 occurred and none is pending, each of these entities shall provide a letter from their
21 respective chief executive officer, chief financial officer, or treasurer (or equivalent
22 position or role) so certifying.

23 In instances where a material change has occurred, or is anticipated, the affected entity
24 shall provide a statement describing each material change in detail, the likelihood that
25 the developments will continue during the period of performance of the Project
26 development, and the projected full extent of the changes likely to be experienced in the
27 periods ahead. Estimates of the impact on revenues, expenses and the change in
28 equity shall be provided separately for each material change. References to the notes
29 in the financial statements are not sufficient to address the requirement to discuss the
30 impact of material changes.

31 Where a material change will have a negative financial impact, the affected entity shall
32 also provide a discussion in the statement of measures that would be undertaken to
33 insulate the Project from any recent material changes, and those currently in progress
34 or reasonably anticipated in the future. If the financial statements indicate that expenses
35 and losses exceed income in the previous fiscal year (even if there has not been a
36 material change), the affected entity shall provide a discussion in the statement of
37 measures that will be undertaken to make the entity profitable in the future and an
38 estimate of when the entity will be profitable.

39 The statement shall be signed and certified by the chief executive officer, chief financial
40 officer, or treasurer (or equivalent position or role).

1 For a non-exclusive list of what ADOT considers to be a material change in financial
2 condition, See RFQ Section 5.2.4. This list is intended to be indicative only.

3 **2.5 Guarantor Commitments**

4 As a condition to execution of the DBM Agreement, Guarantees will be required for a
5 Developer that is newly formed (within two years before the SOQ Due Date) or that
6 does not satisfy the Tangible Net Worth requirements in Section 10.4.6 of the as-
7 issued DBM Agreement. The financial statements of a Guarantor or Guarantors shall
8 demonstrate financial capability of the Proposer and satisfaction of the Tangible Net
9 Worth requirements set forth in Section 10.4.6 of the DBM Agreement.

10 For each proposed Guarantor, in addition to its financial statements, credit ratings and
11 material changes in financial condition, Proposer shall submit a completed and signed
12 Form T (Guarantor Commitment Letter).

5 This Exhibit 4 describes the submission format for Price Proposals and outlines the

7 Proposer shall submit the information required by this Exhibit 4 in the organization and
8 format specified herein. Each component of the Price Proposal shall be clearly titled
9 and identified.

10 All forms named herein are found in Exhibit 5, unless otherwise noted. Pricing forms
11 are provided in Excel formats. All blank spaces (highlighted in yellow) in the pricing
12 forms must be filled in as appropriate. No substantive change shall be made in the
13 pricing forms.

14 **1.1 Format of Price Proposal**

15 All price and cost information provided in the Price Proposal shall be in U.S. Dollar
16 currency only. Take note of instructions on the forms to provide amounts in year of
17 expenditure (YOE) or present value dollars as of the Proposal Due Date.

18 If there are any discrepancies between the hard copy and electronic copy of any
19 quantitative information provided in the Price Proposal, the hard copy version will
20 prevail. If there are any differences between individual line amounts and totals, the
21 individual line amounts will prevail.

22 **1.2 Contents of Price Proposal**

23 All parts of the Proposal that indicate price are to be included in the Price Proposal.

24 The Price Proposal shall consist of price information (including Form M series and Form
25 N series).

26 **SECTION 2 PRICE INFORMATION**

27 **2.1 Price Value**

28 See ITP Section 5.6 for the components of the Price Value. Proposer shall submit Form
29 M-1 which will sum the components of the Price Value. The Excel version of this form
30 will automatically calculate based on information the Proposer enters on other forms.

31 Although the D&C Price forms may show expenditures at any given point in the
32 schedule higher than the then applicable Maximum Allowable Cumulative Draw, ADOT
33 will not pay more than the then applicable Maximum Allowable Cumulative Draw (plus
34 the amount of Supplemental Agreements, if any).

1 **2.2 Design & Construction Price and Cash Flow Adjustment Table/Maximum**

9 The Price Proposal shall include Form M-1.3 which shall set forth any adjustments for
10 avoided Schematic ROW, as provided by ADOT in response to any Pre-Proposal
11 Submittals, that are incorporated into the Proposal. If there are no such adjustments,
12 affirmatively state that there are none. Enter each credit as a value less than or equal to
13 \$0. Refer to ITP Section 5.6.1 for additional information about the credit.

14 The Price Proposal shall include Form M-1.4 indicating (a) a per diem decrease in the
15 D&C Price for each day NTP 3 is issued prior to the start date of the NTP3 Window, up
16 to a cap of 180 days before the start date of the NTP 3 Window and (b) a per diem
17 increase in the D&C Price for each day NTP3 is issued after the end date of the NTP 3
18 Window, up to a cap of 180 days after the end date of the NTP 3 Window. Enter the per
19 diem decrease as a value less than or equal to \$0. For each 30-day interval in the 180-
20 day period, use one value for the per diem increase, and one value for the per diem

31 **2.3 Maintenance Price**

32 The Price Proposal shall include Form N-1 setting forth the summary of the Factored
33 Annual Maintenance Price (composed of escalated and discounted Routine
34 Maintenance and Capital Asset Replacement Work), for Maintenance Services over the
35 duration of an assumed 30-year Maintenance Period. Form N-1 will be automatically
36 calculated from the information the Proposer enters on Form N-1.1 and Form N-1.2.
37 Section 13.5 of the DBM Agreement provides for the adjustment procedures and index
38 for annual adjustments in the price for Maintenance Services.

39 Proposer shall use Form N-1.1 to show the breakdown of Routine Maintenance in 2015
40 \$, using the categories provided. Proposer shall use Form N-1.2 to show the
41 breakdown of Capital Asset Replacement Work in 2015 \$, utilizing the categories
42 provided.

1 **2.4 Insurance Pricing**

2 Forms M-1.1, N-1.1 and N-1.2 require Proposers to separately state the portion of the
3 D&C Price and Maintenance Price allocated to the cost of insurance required by the

Assume all legal liability and financial responsibility for the encroachment activity for the duration of the encroachment, including indemnify, defend, and save harmless ADOT and the State of Arizona and any of its agents, directors, officers, employees from and against any and all claims, demands, suits, actions, proceedings, loss, costs, damages of every kind, or expenses, including court costs, reasonable attorney's fees and/or litigation expenses, and costs of claim processing and investigation, arising out of bodily injury or death of any person, or tangible or intangible property damage, caused, or alleged to be caused, in whole or in part, by the negligent or willful acts, or omissions of the Permittee, any of its directors, officers, agents, employees, or volunteers, or its contractor or subcontractors. This indemnity includes any claim or amount arising out of or recovered under the Workers' Compensation Law or arising out of the contractor's failure to conform to any federal, state or local law, statute, ordinance, rule, regulation or court decree. Permittee agrees to provide ADOT with a certificate(s) of insurance consistent with the requirements stated in the ADOT Permit Insurance Matrix. Permittee is also obligated to provide certificates for its contractor(s), if any. The required insurance shall be kept in force by the permittee and its contractors for the term of the permit and shall not expire, be cancelled or materially changed to affect coverage available to the State without thirty (30) days written notice to the State. Environmental Laws refers collectively to any and all federal, state, or local statute, law, ordinance, code, rule, regulation, permit, order, or decree regulating, relating to, or imposing liability or standards of conduct on a person discharging, releasing or threatening to discharge or release or causing the discharge or release of any hazardous or solid waste or any hazardous substance, pollutant, contaminant, water, wastewater or storm water, and specifically includes, but is not limited to: The Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act; the Comprehensive Environmental Response, Compensation and Liability Act, as amended; the Toxic Substances Control Act; the Clean Water Act (CWA); the Clean Air Act; the Occupational Safety and Health Act; the Arizona Water Quality Act Revolving Fund Act, the Arizona Hazardous Waste Management Act, any applicable National Pollutant Discharge Elimination System (NPDES) or Arizona Pollution Discharge Elimination System (AZPDES) permit, any applicable CWA Section 404 permit, or any local pretreatment or environmental nuisance ordinance.

26 as soon as practicable after the amount is determined by agreement or otherwise, with
27 interest thereon as provided by law, or (ii) denying liability in whole or in part and
28 explaining all reasons therefor.

29 5. If Surety does not proceed as provided in Paragraph 4 of this Bond
30 with reasonable promptness or, as to Paragraph 4.d, within the time stated, then Surety
31 shall be deemed to be in default on this Bond ten days after receipt of an additional
32 written notice from Obligee to Surety demanding that Surety perform its obligations
33 under this Bond, and Obligee shall be entitled to enforce any remedy available to
34 Obligee. If Surety proceeds as provided in Subparagraph 4.d of this Bond, and Surety
35 fails to promptly make payment of the full amount due or Surety has denied liability, in
36 whole or in part, then Obligee shall be entitled to enforce any remedy available to
37 Obligee without further notice.

38 6. If Surety elects to act under Subparagraph 4.a, 4.b, or 4.c above,

26 Obligee acknowledges that it understands the provisions and effect of such statute, has
27 consulted with legal counsel regarding such waiver, and willingly grants such waiver.

2 **(Loop 202 South Mountain Freeway)**

4 THIS STIPEND AGREEMENT is made and entered into as of this _____
5 day of July 2015, by and between the Arizona Department of Transportation (“ADOT”)
6 and _____, a _____
7 (“Proposer”), with reference to the following facts:

8 A. Proposer is one of the shortlisted proposers eligible to submit Proposals
9 for the Loop 202 South Mountain Freeway Project (the “Project”), and wishes to submit
10 a Proposal in response to the Request for Proposals for the Project issued by ADOT on
11 June 12, 2015 (as amended, the “RFP”). Initially capitalized terms not otherwise
12 defined herein shall have the meanings set forth in the RFP.

13 B. The RFP requires each shortlisted proposer to execute and deliver to
14 ADOT a Stipend Agreement by the date specified in the RFP, as a condition to the
15 proposer’s eligibility to receive a stipend in accordance with Section 6.3 of the
16 Instructions to Proposers (“ITP”).

17 NOW, THEREFORE, ADOT and the Proposer hereby agree as follows:

18 **1. PERFORMANCE AND WORK PRODUCT**

19 (a) Subject to the provisions of the DBM Agreement regarding ownership of
20 DPDs, and except in circumstances where the stipend amount under Section 2(b) is \$0:

21 (i) all work product of Proposer and its team members contained in its
22 Technical Proposal or generated by or on behalf of Proposer for the purpose of
23 developing its Technical Proposal (including technologies, techniques, methods,
24 processes, drawings, reports, plans, specifications, information, documents,
25 concepts (including ATCs), ideas, data and information gathered and reports
26 prepared from any surveys or site investigations by or on behalf of Proposer, and
27 other materials in the Technical Proposal) (collectively the “Work Product”) shall
28 be considered work for hire; and

29 (ii) the Work Product shall become the property of ADOT which ADOT
30 may use at its sole discretion and risk, without restriction or limitation.

31 (b) Neither Proposer nor any of its team members shall copyright any of the
32 Work Product.

33 **2. COMPENSATION AND PAYMENT**

34 (a) Subject to the terms of this Section 2 and Section 6.3 of the ITP, ADOT
35 agrees to pay Proposer for the Work Product a lump sum stipend equal to the lesser of
36 (i) \$2,000,000 (the “Maximum Stipend Amount”) and (ii) the full amount of Proposer’s
37 actual, reasonable and documented out-of-pocket development costs actually incurred

1 and paid by Proposer with respect to preparing Proposer's Technical Proposal (which
 2 costs ADOT has determined are a reasonable measure of the value of the Work
 3 Product received); provided, however, if ADOT cancels the procurement after official
 4 issuance of the RFP but prior to the Proposal Due Date, then the applicable Maximum
 5 Stipend Amount shall equal the following:
 6

7 (b) As a condition to Proposer's entitlement to this payment, Proposer shall
 8 deliver to ADOT all Work Product that Proposer has developed for the Project. ADOT
 9 shall be under no obligation to make this payment if Proposer withholds Work Product
 10 that is not otherwise exempt from submittal under this Stipend Agreement or the RFP.

11 (c) Notwithstanding Section 2(a), no stipend shall be payable to a Proposer in
 12 the following circumstances:

13 (i) if ADOT withdraws the RFP prior to the deadline for submission of
 14 ATCs, as such deadline may be extended;

15 (ii) if Proposer withdraws from the procurement at any time prior to the
 16 Proposal Due Date, or fails to submit a Proposal;

17 (iii) if the Proposal is submitted after the deadline on the Proposal Due
 18 Date or is submitted by such deadline but determined by ADOT in its good faith
 19 discretion to be non-responsive, and/or to not achieve a passing score on any of
 20 the pass/fail criteria in Section 5.3 of the ITP. A "responsive" Proposal means a
 21 Proposal submitted by a shortlisted proposer which conforms in all material
 22 respects to the requirements of the RFP, as determined by ADOT in its good
 23 faith discretion;

1 (iv) if Proposer has not fully complied with the terms and conditions of
2 the RFP, including any circumstance that under the terms and conditions of the
3 RFP entitles ADOT to draw on the Proposer's Proposal Security;

4 (v) if Proposer has not fully complied with the terms and conditions set
5 forth in this Stipend Agreement, including delivery to ADOT of an invoice, an
6 executed transfer of rights, release of claims and waiver of protest, and all Work
7 Product, in accordance with the conditions set forth in Section 2(d);

8 (vi) if Proposer has filed a protest, including any protest of a
9 cancellation of the procurement, or any statement in support of another
10 Proposer's protest, except a protest under Section 8.1(a) of the ITP that is
11 resolved through ADOT's issuance of an Addendum; or

12 (vii) if Proposer is selected for conditional or final award (whether as the
13 Preferred Proposer or next best value Proposer) and it:

14 (A) ADOT proceeds with final award as described in the RFP; or

15 (B) Proposer fails to satisfy the award conditions set forth in
16 Section 6.1.1(b), (c) and (d) of the ITP or fails to proceed with final award
17 as described in the RFP for any reason (including failure to negotiate in
18 good faith) other than (I) failure of one or more express closing
19 contingencies for the benefit of Proposer that are set forth in the RFP, the
20 failure of which does not arise out of or result from the acts, omissions,
21 negligence, fraud, breach of contract or law or willful misconduct of
22 Proposer; or (II) ADOT's election to cancel the procurement after the
23 Proposal Due Date, which election does not arise out of or result from the
24 acts, omissions, negligence, fraud, breach of contract or law or willful
25 misconduct of the Proposer.

26 (d) ADOT will make payment within 30 days after ADOT receives, within the
27 applicable time frame set forth in Section 2(e) below:

28 (i) a proper invoice, in the form attached to this Agreement as
29 Attachment 1, with supporting documentation of Proposer's claimed costs;

30 (ii) an executed irrevocable transfer of rights, full release of all claims
31 and waiver of protest against ADOT, in the form attached to this Agreement as
32 Attachment 2; and

33 (iii) the Work Product.

34 (e) Proposer may submit the invoice with supporting documentation, transfer
35 of rights, release of claims and waiver of protest conditioned on receipt of ADOT's
36 payment, and Work Product only within the following applicable time frame:

37 (i) If ADOT cancels the procurement prior to or following the Proposal
38 Due Date, then no earlier than the date of notice of cancellation and no later than
39 120 days after the date of the notice of cancellation;

1 (ii) If ADOT does not cancel the procurement but the time period for
2 award stated in the RFP (plus any extension thereof by mutual agreement of the
3 apparent best value Proposer and ADOT, as set forth in emailed notice from
4 ADOT) expires, then no earlier than the date such time period expires and no
5 later than 120 days after the date such time period expires; or

6 (iii) If ADOT does not cancel the procurement and awards the DBM
7 Agreement to another proposer within the time period for award stated in the
8 RFP (plus any extension thereof by mutual agreement of the apparent best value
9 Proposer and ADOT, as set forth in emailed notice from ADOT), then no earlier
10 than 30 days and no later than 120 days after notice of final award, including
11 execution of the DBM Agreement, is emailed to Proposer.

12 **3. INDEMNITIES; DISCLAIMERS**

13 (a) Proposer agrees that it will indemnify, defend, protect and hold harmless
14 ADOT and all of ADOT's board members, officers, agents, representatives, and
15 employees from any claim, loss, damage, cost, judgment, fee, penalty, charge, or
16 expenses (including attorneys' fees and costs) to the extent arising out of (i) any acts,
17 actions, neglect, omissions, fault, willful misconduct, violation of law or breach by
18 Proposer, its agents, employees, or contractors or subcontractors during the
19 performance of this Stipend Agreement, whether direct or indirect, and whether to any
20 person or property to which ADOT or said parties may be subject, except that neither
21 Proposer nor any of its contractors will be liable under this section for any claim, loss,
22 damage, cost, judgment, fee, penalty, charge or expense arising out of injury or damage
23 to persons or property directly caused or resulting from the comparative negligence of
24 ADOT or any of its board members, officers, agents, or employees, or (ii) any actual or
25 alleged patent or copyright infringement or other actual or alleged improper
26 appropriation or use of trade secrets, patents, propriety information, know-how,
27 copyright rights or inventions in connection with the Work Product, except that this
28 indemnity shall not apply to any infringement to the extent resulting from ADOT's failure
29 to comply with specific written instructions regarding use provided to ADOT by
30 Proposer.

31 (b) Proposer's obligation to indemnify, defend, protect and pay for the defense
32 or, at ADOT's option, to participate and associate with ADOT in defense of any claim
33 and any related settlement negotiations, shall be triggered by ADOT's notice of claim for
34 indemnification to Proposer. Only a final and non-appealable order or judgment
35 specifically finding ADOT negligent shall excuse performance of this provision, and then
36 only to the extent of ADOT's comparative liability. Proposer shall pay all costs and fees
37 related to this obligation and its enforcement by ADOT. ADOT's failure to notify
38 Proposer of a claim shall not release Proposer of the above duty to indemnify.

39 (c) ADOT's use of the Work Product shall be at ADOT's sole discretion and
40 risk, and in no way shall be deemed to confer liability or indemnity obligation on
41 Proposer. Proposer shall not be liable to ADOT or any other person for any claim, loss,
42 damage, cost, judgment, fee, penalty, charge or expense (including attorneys' fees and
43 costs) to the extent arising out of or resulting from use of Work Product by ADOT,
44 Developer or any of their respective board members, officers, agents or employees.

1 Except as set forth in the invoice, Proposer makes no warranty or representation,
2 express or implied, regarding the Work Product or its suitability for any intended
3 purpose. The provisions of this clause (c) shall not, however, negate or limit
4 Developer's indemnities in Section 3(a) above.

5 **4. COMPLIANCE WITH LAWS**

6 (a) Proposer acknowledges that all written correspondence, exhibits,
7 photographs, reports, printed material, tapes, electronic disks, and other graphic and
8 visual aids submitted to ADOT during this procurement process are, upon their receipt
9 by ADOT, subject to the Public Records Act (Arizona Revised Statutes title 39).

10 (b) Proposer shall comply with all federal, state, and local laws; ordinances;
11 rules; and regulations applicable to the work or payment therefor, and shall not
12 discriminate on the grounds of race, color, religion, sex, national origin, age, or disability
13 in the performance of work under this Stipend Agreement.

14 (c) Proposer agrees to incorporate the provisions of this Section 4 in any
15 subcontract into which it might enter with reference to the work performed pursuant to
16 this Stipend Agreement.

17 **5. EARLY TERMINATION**

18 This Stipend Agreement may be terminated by ADOT, in its sole discretion, in
19 whole or in part, at any time. In the event of such termination, ADOT will owe no
20 payment, except as provided in Section 2.

21 **6. ASSIGNMENT**

22 Proposer shall not assign, transfer, pledge, sell, or otherwise convey this Stipend
23 Agreement without ADOT's prior written consent, in its sole discretion. Any assignment
24 of this Stipend Agreement without such consent shall be null and void and may, in
25 ADOT's sole discretion, disqualify Proposer from further consideration for the
26 procurement and Project.

27 **7. MISCELLANEOUS**

28 (a) Proposer and ADOT agree that Proposer, its equity owners, team
29 members, and their respective employees are not agents or representatives of, or joint
30 venturers with, ADOT as a result of this Stipend Agreement.

31 (b) All words used herein in the singular form shall extend to and include the
32 plural. All words used in the plural form shall extend to and include the singular. All
33 words used in any gender shall extend to and include all genders.

34 (c) This Stipend Agreement, together with the RFP, embody the entire
35 agreement of the parties with respect to the subject matter hereof. There are no
36 promises, terms, conditions, or obligations other than those contained herein or in the
37 RFP, and this Stipend Agreement shall supersede all previous communications,
38 representation, or agreements, either verbal or written, between the parties hereto.

1 (d) It is understood and agreed by the parties hereto that if any part, term, or
2 provision of this Stipend Agreement is by the courts held to be illegal or in conflict with
3 any law of the State of Arizona, the validity of the remaining portions or provisions shall
4 not be affected, and the rights and obligations of the parties shall be construed and
5 enforced as if the Stipend Agreement did not contain the particular part, term, or
6 provisions to be invalid.

7 (e) This Stipend Agreement shall be governed by and construed in
8 accordance with the laws of the State of Arizona. The venue for any proceeding
9 relating to this Stipend Agreement shall be in the Superior Court for Maricopa County,
10 Arizona.

11 (f) This instrument may be executed in one or more counterparts, each of
12 which shall be deemed an original, but all of which together shall constitute one and the
13 same instrument.
