ECONOMIC HIGHLIGHTS


Arizona Indicators

- Combined container volume at the Port of Los Angeles and Port of Long Beach was 39.2 percent higher in February 2016 than in February 2015. Last January and February, before an agreement for a new 5-year contract between the Pacific Maritime Association (PMA) and the International Longshore and Warehouse Union (ILWU) was reached, the severity of the congestion at the west coast ports had made headlines.
- The U.S. Energy Information Administration reported the price of West Coast No 2 diesel was \$2.22 per gallon in February 2016, down from \$2.97 per gallon in February 2015. The Arizona average price per gallon for regular unleaded gas was 1.54 in February 2016, compared to \$2.29 in February 2015.
- The Arizona seasonally adjusted unemployment rate, as reported by the Arizona Department of Administration, fell from 6.3 percent in February 2015 to 5.5 percent in February 2016.

Greater Phoenix Area Indicators


- The number of new single-family building permits issued in Maricopa County in February 2016 grew 32.3 percent compared to the same month of 2015. Estimated single-family building permits issued in Maricopa County have been experiencing significant year-over-year growth since February 2015, making February 2016 the thirteenth consecutive month with year-over-year growth.
- The February Employment Report published by the Arizona Department of Administration stated the construction sector in the Greater Phoenix Area gained 7,200 jobs year-over-year from February 2015 to February 2016, an increase of 7.5 percent.
- The Greater Phoenix Area unadjusted unemployment rate was 4.6 percent in February 2016, down from 5.4 percent in February 2015.

Maricopa County New Single-Family Building Permits




HIGHWAY USER REVENUE FUND (HURF) THROUGH MARCH 31, 2016


Highlights

- All six revenue categories of HURF experienced positive year to date growth rates in FY 2016 when compared to FY 2015.
- Arizona gas prices rose in March, with the Arizona average price per gallon rising to \$2.09 for regular unleaded gas. Even with the rise in prices, Arizona gas prices were 27 cents per gallon lower than they were in March of last year.
- Year to date new car registrations and new to Arizona registrations are up 2.3 percent and 13.3 percent respectively from the same period of FY 2015.




REGIONAL AREA ROAD FUND (RARF) THROUGH FEBRUARY 29, 2016


Highlights

- Retail sales, the largest revenue category of RARF, grew
 7.8 percent in the first eight months of FY 2016 when compared to the same period of the prior year.
- Meanwhile, the contracting category of RARF decreased 13.7 percent in the first eight months of FY 2016 when compared to the same period of the prior year.
- Some of the year-over-year changes in the retail sales and contracting categories of RARF can be explained by legislation taking effect in February 2015 that moved taxes collected on certain contracting activities from the contracting revenue category to the retail revenue category. Since these changes were anticipated, retail sales revenues are tracking only 1.8 below estimate and contracting revenues are 2.7 percent below the estimate.
