### **ECONOMIC HIGHLIGHTS**


#### **Arizona Indicators**

- Combined container volume at the Port of Los Angeles and the Port of Long Beach was 11.9 percent lower in February 2017 than in February 2016.
- The U.S. Energy Information Administration reported the price of West Coast No 2 diesel was \$2.87 per gallon in February 2017, up from \$2.22 per gallon in February 2016. The Arizona average price per gallon for regular unleaded gas was \$2.18 in February 2017, compared to \$1.80 in February 2016.
- The Arizona seasonally adjusted unemployment rate, as reported by the Arizona Office of Economic Opportunity, fell from 5.5 percent in February 2016 to 5.1 percent in February 2017.

#### **Greater Phoenix Area Indicators**


- The number of new single-family building permits issued in Maricopa County in February 2017 rose 3.6 percent compared to the same month of 2016. The 1,252 permits issued in February 2017 are 37.1 percent higher than the 913 permits issued in February 2015.
- The February Employment Report published by the Arizona Office of Economic Opportunity stated the construction sector in the Greater Phoenix Area gained 2,100 jobs year-over-year from February 2016 to February 2017, an increase of 2.1 percent.
- The Greater Phoenix Area unadjusted unemployment rate was 4.4 percent in February 2017, down from 4.5 percent in February 2016.

# Maricopa County New Single-family Building Permits




## HIGHWAY USER REVENUE FUND (HURF) THROUGH MARCH 31, 2017


#### **Highlights**

- Year-to-date revenues in HURF's largest category, gas tax, have increased 1.8 percent compared to the same period last year.
- Arizona gas prices rose in March, with the Arizona average price per gallon increasing seven cents to \$2.25 for regular unleaded gas. Arizona gas prices were 17 cents per gallon higher than they were in March of last year.
- In the first nine months of FY 2017, vehicle license tax revenues grew 6.3 percent compared to the same period last year. Vehicle renewal registrations and new car registrations are up 3.9 percent and 6.9 percent, respectively, over the same period.




## REGIONAL AREA ROAD FUND (RARF) THROUGH FEBRUARY 28, 2017


#### **Highlights**

- Total year-to-date RARF revenue in FY 2017 surpassed revenue in the same period of FY 2016 by 4.8 percent and was 1.1 percent above the estimate.
- Retail sales, the largest revenue category of RARF, grew
   5.3 percent year-to-date when compared to the same period last year.
- Year-to-date RARF contracting revenues increased 8.4 percent compared to the same period last year, and was 4.3 percent below forecast. The interest rate on 30 year mortgages in February 2017 was 4.17 percent, higher than the 3.66 percent experienced in February 2016.
