DIESEL TAX

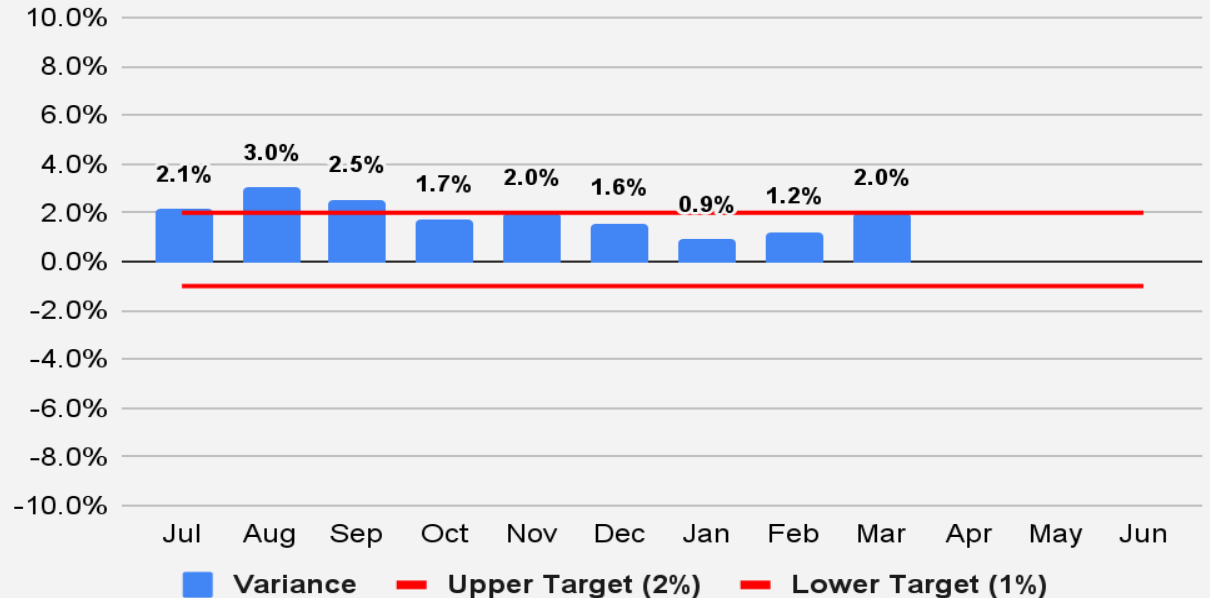
Mar: 8.5%, moderate growth

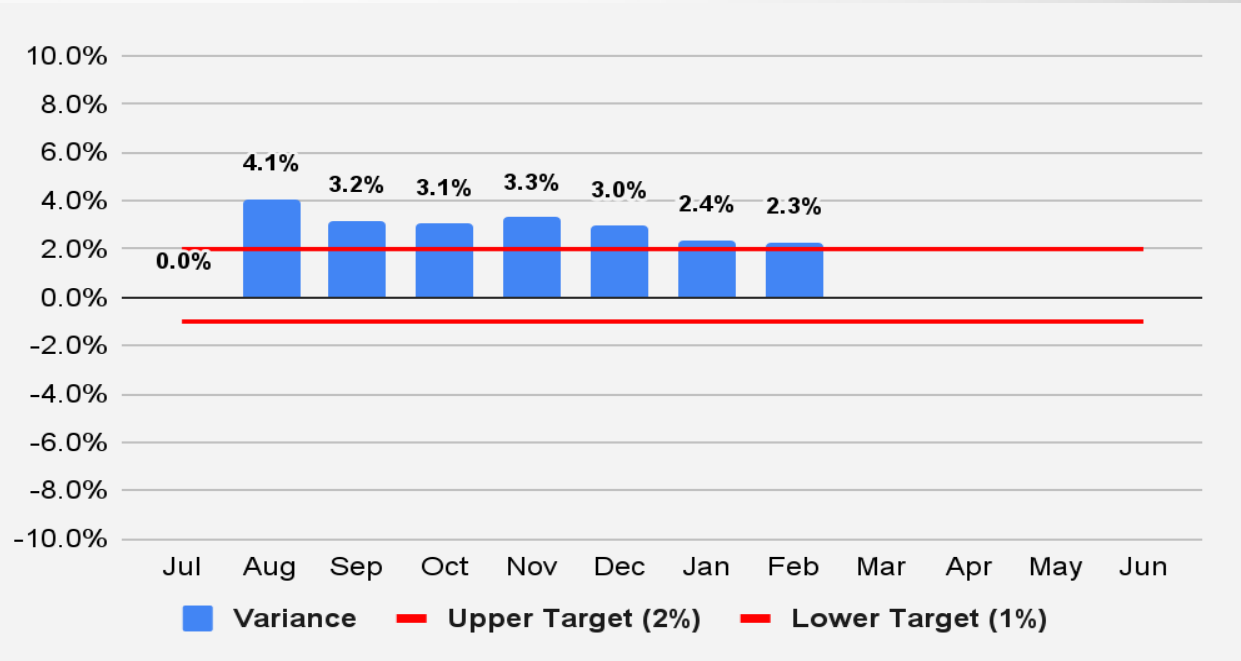
