DIESEL TAX

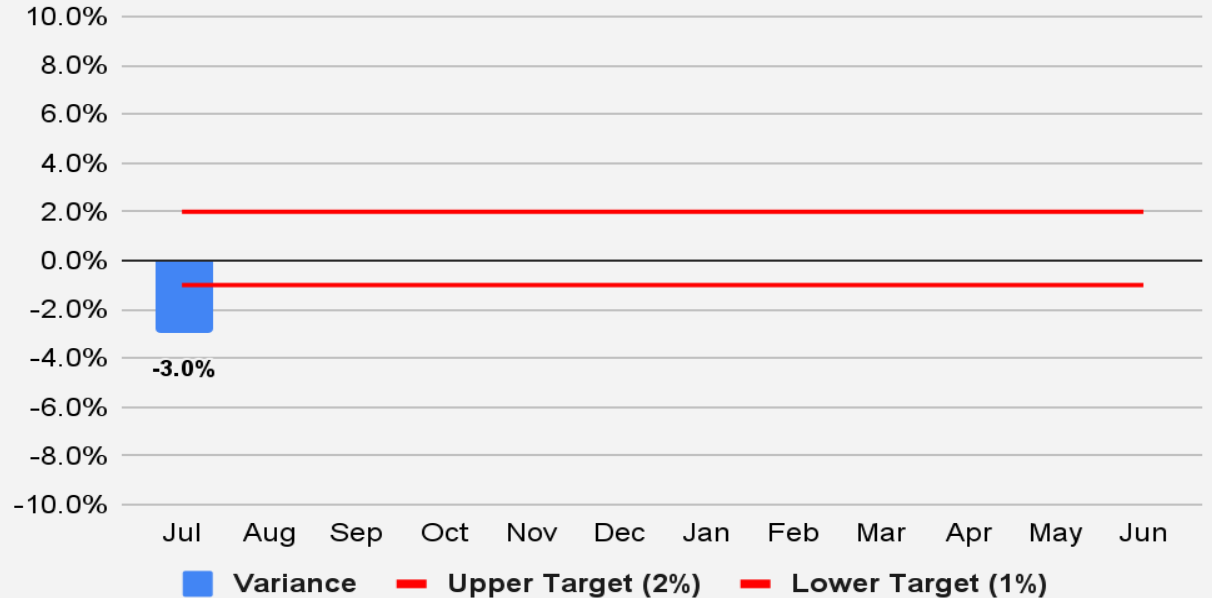
Jul: 14.0%, strong growth

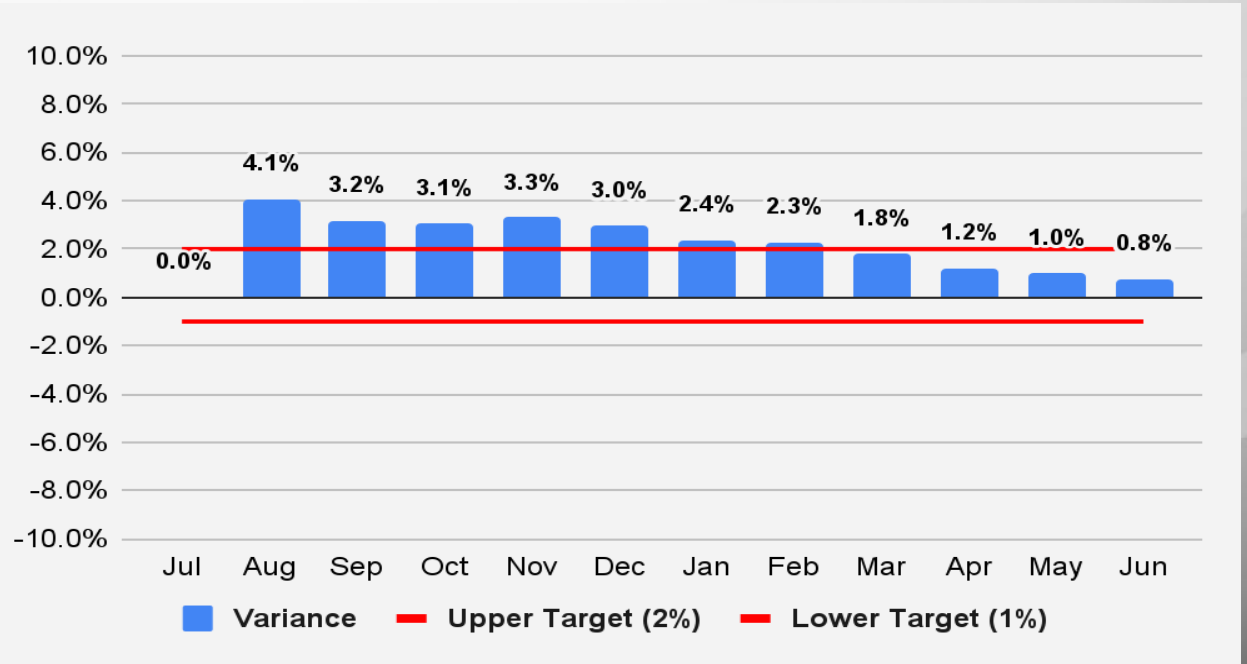
