- 1/ The Maricopa County transporation excise tax became effective on January 1, 1986 per Prop. 300. Prop. 300 collections (effective January 1, 1986 through December 31, 2005) total \$3,791 million but will change over time due to adjustments, refunds and audits.
- 2/ The Regional Public Transportation Authority (RPTA) received a portion of the excise tax funds for transits costs through December 31, 2005. Beginning January 1, 2006, per ARS 28-6305 B and C, a portion of the Freeways 56.2% monies are distributed equally between the Maricopa Association of Governments (MAG) and the Public Transportation Fund (PTF) to be used for planning and administering the regional transportation plan. These funds are netted from the Freeway funds. The amount depicted reflects the transfer amount paid for each fiscal year, not necessarily the fiscal year in which the transfer was made.
- 3/ Reflects the deduction from collections of a fee paid to the Arizona Department of Revenuepursuant to Arizona Revised Statutes section 42-5041 to recover a portion of administrative, program and other operating costs incurred in collecting the transportation excise taxes. FY 2016 to FY 2021 Enacted by Laws 2015, Ch. 323 (HB 2617) and repealed by Laws 2021, Ch. 411 (SB 1827). FY 2023 to FY 2025 Enacted by Laws 2022, Ch. 321 (HB 2871), sections 6 and 18.
- 4/ Prop. 400 became effective on January 1, 2006 and will end on December 31, 2025. The distributions are as follows: Freeways, 56.2%, Arterial Streets, 10.5% and Public Transportation Fund, 33.3%.
