We have reviewed your July 19, 2016 request to amend the FY 2016-2019 Statewide Transportation Improvement Program (STIP) to include the FY 2017-2021 Transportation Improvement Program approved by the Maricopa Association of Governments Regional Council on June 22, 2016.

We accept this Amendment in accordance with 23 CFR 450 and find that this STIP amendment was developed based on a continuing, cooperative and comprehensive transportation planning process in accordance with the 23 USC 134 and Section 5303 of the Federal Transit Act (49 USC 53). The changes made to the program by this action required a new conformity determination [40 CFR §93.126].
