Dear Mr. Halikowski:

We have reviewed Ms. Toth's April 7, 2010 request to amend the FY 2010-2013 Statewide Transportation Improvement Program (STIP) to include the enclosed tables of projects approved by the Central Arizona Association of Governments Regional Council as TIP Amendment 1 on March 24, 2010. Our action on this amendment excludes the table of projects for American Recovery and Reinvestment Act Program II projects funded with future Economic Recovery funds which would violate Fiscal Constraint principles. We will defer any action on this table until those funds become available through an act of Congress.

We accept this Amendment in accordance with 23 CFR 450 and find that this STIP amendment was developed based on a continuing, cooperative and comprehensive transportation planning process in accordance with the 23 USC 134 and Section 5303 of the Federal Transit Act (49 USC 53). The changes made to the program by this amendment are either exempt or are regarded as minor project revisions that do not require conformity determination [40 CFR §93.126].

This letter constitutes partial approval and inclusion of Amendment 25 into the Arizona FY 2010-2013 STIP. Our approval is based upon the Arizona Department of Transportation's assurance that the funding for the project in this amendment will not adversely impact the STIP Financial Plan.
