The subject C-Stds. have been revised and are being issued for use as applicable effective November 1, 2007. The revisions are as follows:

Std. C-07.02 Load Transfer Dowel Assembly - General Note #1 has been revised to reflect that the assemblies "may" be used rather than "shall" be used. Current construction methodology places dowels by mechanical insertion and no longer requires the use of dowel basket assemblies.

Std. C-21.10 Survey Monument Frame and Cover and C-21.20 Survey Marker - The drawings have been revised to remove references to Right-of-Way monumentation and Right-of-Way markers as they are covered under separate drawings included in the ADOT R/W Plans Section Right-of Way Monumentation Procedures and Standards.
