SUBJECT: LOBBYING CERTIFICATION AND DISCLOSURE CERTIFICATE PROCEDURES

The purpose of this bulletin is to inform the consultant community of the need to comply with Section 1352 of Title 31, U.S. Code (Public Law 101.121). These provisions have also been codified in Title 48 - Federal Acquisition Regulations Subpart 3.8 and Subpart 52.203-11.

The law generally prohibits recipients of Federal contracts, grants and loans from using appropriated funds for lobbying activities. It also requires disclosure of lobbying activities that, while permitted, cannot be paid for with appropriated funds.

The law has broad application affecting, but not limited to, the following programs involving the Highways Division:

- * Federal-Aid Highway Contractors and Consultants
- * State and Local Government Agencies
- * Metropolitan Planning Organizations
- * Lower Tier Recipients and Contractors, except Indian Tribes or Tribal Organizations.

The law prohibits Federal funds from being expended by a recipient or any lower tier subrecipients of a Federal contract, grant, loan, or cooperative agreement to pay any person for influencing or attempting to influence a Federal agency or Congress in connection with the awarding of any Federal cooperative agreement. The extension, continuation, renewal, amendment or modification of any Federal contract, grant, loan or cooperative agreement is covered.

The process for certification and disclosure will apply to all agreements administered by Engineering Consultants Services. No attempt will be made to differentiate between funding sources, since during the course of an agreement the source of the funds may change.

The requirement for the above information applies to new contracts and the issuance of change orders over \$100,000 for the prime or any subconsultants. If a change order is issued for less than \$100,000 and subsequently exceeds that total the required certification will need to be completed before the agreement is executed.

Prior to the acceptance of any Request for Proposals, Technical Proposals or other submittals as specified by Engineering Consultants Services, a Lobbying Certification and when appropriate, a Disclosure Certification will need to be filed by the Prime Consultant.

- Certification and when appropriate, a Disclosure Certificate from subconsultants will need to be submitted prior to execution of agreement.
- For active contracts, the required forms will be needed prior to the execution of the change order agreement.

The Certification forms are submitted to and retained by the next higher level. Accordingly, ECS will retain Certification forms from the Prime Consultants, which in turn will retain the forms from the subconsultants.

All Disclosure Certificates, ECS Form 90-3, are to be submitted through the contracting levels to ECS, then to the FHWA Division office. The instructions accompanying Form 90-3 discuss where this form is required.

The contract provision may read as follows:


Anti-Lobbying:

The Consultant agrees to require all lower tier subconsultants who have agreements exceeding \$100,000 to complete the Certification of Federal Aid Contracts (ECS Form 90-1) and when appropriate, the Disclosure of Lobbying Activities (ECS Form 90-3) prior to execution of the Prime Consultants Agreement with the Department. Lower tier certifications should be maintained by the next tier above (i.e., prime consultants will keep the subconsultants certification on file, etc.)

Engineering Consultants Services will include in all contract advertisements the following: "Lobbying Certification/Disclosure Certificate will be required from those selected for the shortlist". Variations of this wording will also appear in advertisements for Request For Proposals or for Special Statements of Interest which do not require a Technical Proposal.

Certification for Federal Aid Contracts

Applies to: Federal-aid contractors, and consultants, as well as lower tier subcontractors and subconsultants.

The prospective participant certifies, by signing and submitting this bid or proposal, to the best of his or her knowledge and belief, that:

(1) No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

(2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed by Section 1352, Title 31, U.S. Code. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

The prospective participant also agrees by submitting his or her bid or proposal that he or she shall require that the language of this certification be included in all lower tier subcontracts, which exceed \$100,000, and that all such subrecipients shall certify and disclose accordingly.

Certification for Grants, Loans, and Cooperative Agreements

Applies to Local agencies, Metropolitan Planning Organizations, and any other subgrantees (exclusive of Indian tribes, and tribal or Indian organizations).

The undersigned certifies, to the best of his or her knowledge and belief, that:

(1) No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

(2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

(3) The undersigned shall require that the language of this certification be included in the award documents for all subawards at all tiers (including subgrants, and contracts and subcontracts under grants, subgrants, loans, and cooperative agreements) which exceed \$100,000, and that all such subrecipients shall certify and disclose accordingly.

Submission of this certification is a prerequisite for making or entering into this transaction imposed by Section 1352, Title 31, U.S. Code. INSTRUCTIONS FOR COMPLETION OF SF-LLL, DISCLOSURE OF LOBBYING ACTIVITIES

This disclosure form shall be completed by the reporting entity, whether subawardee or prime Federal recipient, at the initiation or receipt of a covered Federal action, or a material change to a previous filing, pursuant to title 31 U.S.C. section 1352. The filing of a form is required for each payment or agreement to make payment to any lobbying entity for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with a covered Federal action. Use the SF-LLL-A Continuation Sheet for additional information if the space on the form is inadequate. Complete all items that apply for both the initial filing and material change report. Refer to the implementing guidance published by the Office of Management and Budget for additional information.

1. Identify the type of covered Federal action for which lobbying activity is and/or has been secured to influence the outcome of a covered Federal action.
2. Identify the status of the covered Federal action.
3. Identify the appropriate classification of this report. If this is a followup report caused by a material change to the information previously reported, enter the year and quarter in which the change occurred. Enter the date of the last previously submitted report by this reporting entity for this covered Federal action.

12. Check the appropriate box(es). Check all boxes that apply. If payment is made through an in-kind contribution, specify the nature and value of the in-kind payment.
13. Check the appropriate box(es). Check all boxes that apply. If other, specify nature.
14. Provide a specific and detailed description of the services that the lobbyist has performed, or will be expected to perform, and the date(s) of any services rendered. Include all preparatory and related activity, not just time spent in actual contact with Federal officials. Identify the Federal official(s) or employee(s) contacted or the officer(s), employee(s), or Member(s) of Congress that were contacted.
15. Check whether or not a SF-LLL-A Continuation Sheet(s) is attached.
16. The certifying official shall sign and date the form, print his/her name, title, and telephone number.
