## **ADOT goes BIG in 2022**

HAVE YOU HEARD the expression "Go big or go home?" It means to act boldly. By reflecting on what we have begun or accomplished so far, I can wholeheartedly say ADOT has gone BIG in 2022.

### **Big transportation projects in 2022**

Improving safety while enhancing commerce and economic development was the focus of the State Route 189 project in Nogales, which opened in March. This project was a huge success for the region and showcases the importance of international trade between Mexico and Arizona.

With construction already underway, the I-10 Broadway Curve project is the largest urban freeway reconstruction project ADOT has undertaken. If you drive Interstate 10 in the East Valley, you can see the progress the team is making in improving this important 11-mile stretch of freeway.

Relief is coming to Interstate 17 north of Phoenix with the I-17 Flex Lane project. It improves 23 miles of interstate and installs an eight-mile flex lane system — a new feature for Arizona's highway system.

This photo shows the new Broadway Road bridge deck pour over eastbound Interstate-10 lanes as part of the I-10 Broadway Curve Improvement Project. The deck is the portion of the bridge that motorists will drive on.

ADOT is finishing the study to widen Interstate 10 between Loop 202 and State Route 387. This segment, known as the Wild Horse Pass Corridor, represents the last stretch of interstate between Phoenix and Casa Grande to be enhanced as a Key Commerce Corridor.

We have been installing fiber-optic cable in our rightof-way along the interstates as part of the state's broadband initiative, in partnership with the Arizona Commerce Authority. This effort will enhance internet connectivity to many rural communities in our state.

We have other projects to complete around the state due to the generosity of the Arizona State Legislature and the monies from the federal Infrastructure Investment and Jobs Act.

Transportation was a big winner in 2022 when it comes to federal and state appropriations.

Jamila Brown oversaw the contest as project manager. She worked with calendar committee members Karen Eatherly, Leah Almond, Marcella Gonzalez-Reyes and Christine Baptisto, along with Viridiana "Genesis" Meraz, who designed the calendar, and Gabriel Meza, who helped get the calendars printed. # ADOT seeks public comments about DBE goals for federally funded projects

ADOT is gathering public input about the Disadvantaged Business Enterprise (DBE) program's new goals.

Every three years, ADOT must set overall goals and obtain public input for DBE participation in federally funded transportation contracts. Comments are being accepted through Dec. 30 regarding goals set in the 2022 DBE Availability Study.

"The new study determines the availability of women- and minority-owned companies to participate in ADOT work. Information from the study will help ADOT evaluate and refine our efforts to encourage the participation of minority- and womenowned businesses in contracts and help inform any adjustments that ADOT might make to the implementation of the DBE Program," said Contract Compliance and Training Officer **Gabe Demarbiex**, who works in the Business Engagement and Compliance Office (BECO).
