Arizona Test Method 421, "BITUMINOUS MATERIAL CONTENT OF ASPHALTIC CONCRETE MIXTURES BY THE NUCLEAR METHOD".

This test method replaces all previous Interim editions of this procedure.

Arizona Test Method 422, "COMPACTION AND TESTING OF BITUMINOUS MIXTURES UTILIZING 152.4 mm (SIX INCH) MARSHALL APPARATUS".

Arizona Test Method 732, "CALCIUM CARBONATE IN TOPSOIL (NEUTRALIZATION POTENTIAL OF TOPSOIL)".

Arizona Test Method 240a, "SIEVE ANALYSIS AND SEPARATION OF SALVAGED AC PAVEMENT PARTICLES FOR RECYCLED ASPHALTIC CONCRETE".
