Pursuant to Arizona Revised Statutes (ARS) section 28-8384, the above Surety, a corporation duly organized under the laws of the above Surety State and duly authorized by the Arizona Department of Insurance and Financial Institutions to conduct general surety business in the State of Arizona, and the above Principal are held and firmly bound unto the State of Arizona in the sum of \_\_\_\_\_ Dollars (\$ \_\_\_\_\_) lawful money of the United States, to be paid to the State of Arizona, or its successors and assigns, for which sum Surety and Principal shall be bound, together with their respective heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

Whereas, the above Principal made application to the Arizona Department of Transportation (ADOT), MVD Aircraft Registration Unit for aircraft dealer pursuant to ARS Title 28 Chapter 25 Article 5 and has made application to the Arizona Department of Revenue (DOR) for an Arizona tax privilege license, Authorizing Principal to engage in business as an aircraft dealer.

If said eligible purchaser status is granted, on and after the effective date thereof, this bond shall secure the faithful payment and performance by Principal of all applicable duties and obligations of Principal pursuant to ARS Title 28 Chapter 25 Article 5, including, but not limited to, the timely filing of reports and payment of all taxes, interest, penalties and related amounts, and any and all additional duties as may be lawfully imposed on Principal pursuant to State of Arizona and the Rules and Regulations of the ADOT. Bounded principal shall faithfully observe and perform the duties imposed upon him by the laws of State of Arizona and Rules and Regulations of ADOT and DOR, and not cause any person to suffer loss, cost, damage, or expense by the failure of the principal so the perform then this obligation shall be null and void; otherwise to remain in full force and effect.

The limit of the liability of Surety is that of the above sum, regardless of the length of time following the date hereof. No person other than the State of Arizona or its successors and assigns shall have any right under this bond.

If Surety shall elect, liability under this bond may be terminated by it upon 60 days written notice to Department, delivered to the above address, in which event said termination of liability shall be effective at the end of the 60 day period, as provided by law, unless prior to such time a new bond shall have been filed by Principal and accepted by Department, in which event such termination shall be effective from the effective date of the new bond. Notice of termination of liability shall not affect the liability of Surety hereunder for acts or omissions of Principal occurring prior to the effective date of termination, and Surety shall continue to be liable therefor to the same extent as if notice of termination had not been given.

This bond shall continue in full force and effect until the surety has terminated future liability after sixty (60) days' notice to the ADOT MVD Aircraft Registration Unit.
