- All services provided by the Third Party must be posted, along with the corresponding service fee charged to complete the customer transaction, and the total of the MVD fee and the Third Party convenience fee.
- Third Parties that charge different amounts of convenience fees for non-members and members must show the most charged, and then can list a bulleted item below which will inform customers that if they are a member, the fee will be less. Or could have a member and non-member column to show the difference convenience fees charged. Third Parties charging convenience fee unrelated to above must list those items under Misc column.
