This fuel tax exemption applies to motor vehicle fuel or use fuel that is:

- Sold within the boundaries of the tribal reservation
- Sold to the enrolled member of the tribe indicated above, who is living on the reservation
- Used by the enrolled member for the member's own benefit

The exemption **does not apply** to use fuel used to operate motor vehicles for a commercial purpose on the highways of this state outside the reservation.

Applications must be completed in full and mailed to the address above, and must be submitted within six months from the date the fuel was purchased or invoiced. If the allowable claim is for less than \$10, only one request may be submitted in a consecutive six month period.

Attach a copy of purchase invoices/receipts for all gallons claimed, a copy of your vehicle registration, and a copy of your tribal enrollment card. These documents **must be submitted** with this application.
