Attach a copy of Fuel purchase invoices and Transactional Report. Transactional report must contain: Tribal Member No., Driver License No., Member's Name, Member's Address, Date of Fuel Purchase, Type of Fuel Purchased, Gallons Purchased and Amount of Exemption sorted and subtotaled by Tribal Member No. These documents **must be submitted** with this application.

Applications must be completed in full and mailed to the address above, or submitted online at <u>AZMVDNow.gov</u>. The application must be submitted within six months from the date the fuel was purchased or sold. If the allowable claim is for less than \$10, only one request may be submitted in a consecutive six month period.
